- 5 § 1901. LEGISLATIVE FINDINGS.
- 6 (A) RECOGNITION OF CONTRIBUTIONS.--THE GENERAL ASSEMBLY
- 7 RECOGNIZES THE GREAT CONTRIBUTIONS AND UNSELFISH SACRIFICES MADE
- 8 BY PENNSYLVANIA SERVICE PEOPLE DURING ARMED CONFLICTS IN WHICH
- 9 THE UNITED STATES WAS A PARTICIPANT.
- 10 (B) ABSENCE OF MEMORIAL.--THE GENERAL ASSEMBLY FURTHER
- 11 RECOGNIZES THAT NO ADEQUATE, APPROPRIATE AND PERMANENT MEMORIAL
- 12 HAS EVER BEEN ERECTED IN APPRECIATION OF AND IN TRIBUTE TO THOSE
- 13 PENNSYLVANIA SERVICE PEOPLE WHO GAVE DEVOTED AND DEDICATED
- 14 SERVICE TO THEIR COUNTRY AND THE COMMONWEALTH.
- 15 (C) ERECTION OF MEMORIAL.--THE GENERAL ASSEMBLY BELIEVES
- 16 THAT, IN CONSIDERATION OF THE FOREGOING, A POSITIVE, PERMANENT
- 17 AND PATRIOTIC MEMORIAL SHOULD BE ERECTED ON THE GROUNDS OF THE
- 18 INDIANTOWN GAP NATIONAL CEMETERY IN APPRECIATION OF THE FULL
- 19 MEASURE OF DEVOTION GIVEN BY PENNSYLVANIA'S VETERANS.
- 20 § 1902. DEFINITIONS.
- 21 THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS CHAPTER
- 22 SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS SECTION UNLESS THE
- 23 CONTEXT CLEARLY INDICATES OTHERWISE:

- 28 § 1903. PENNSYLVANIA VETERANS' MEMORIAL COMMISSION.
- 29 (A) ESTABLISHMENT.--THERE IS ESTABLISHED THE PENNSYLVANIA
- 30 VETERANS' MEMORIAL COMMISSION TO ERECT ON THE GROUNDS OF THE

- 1 INDIANTOWN GAP NATIONAL CEMETERY AN APPROPRIATELY PATRIOTIC AND
- 2 POSITIVE PHYSICAL MONUMENT OR MEMORIAL AS A TESTAMENT OF
- 3 APPRECIATION FROM THE COMMONWEALTH TO THOSE PENNSYLVANIA SERVICE
- 4 PERSONS WHO SERVED IN ARMED CONFLICTS IN WHICH THE UNITED STATES
- 5 WAS A PARTICIPANT.
- 6 (B) COMPOSITION OF COMMISSION. -- THE COMMISSION SHALL BE
- 7 COMPOSED OF THE FOLLOWING:
- 8 (1) TWO MEMBERS OF THE SENATE TO BE APPOINTED BY THE
- 9 PRESIDENT PRO TEMPORE OF THE SENATE, ONE FROM THE MAJORITY
- 10 PARTY AND ONE FROM THE MINORITY PARTY. PREFERENCE SHALL BE
- 11 GIVEN TO HONORABLY DISCHARGED VETERANS.
- 12 (2) TWO MEMBERS OF THE HOUSE OF REPRESENTATIVES TO BE
- APPOINTED BY THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, ONE
- 14 FROM THE MAJORITY PARTY AND ONE FROM THE MINORITY PARTY.
- 15 PREFERENCE SHALL BE GIVEN TO HONORABLY DISCHARGED VETERANS.
- 16 (3) THE SECRETARY OF GENERAL SERVICES, OR A DESIGNEE.
- 17 (4) THE EXECUTIVE DIRECTOR OF THE PENNSYLVANIA
- 18 HISTORICAL AND MUSEUM COMMISSION, OR A DESIGNEE.
- 19 (5) ONE MEMBER, APPOINTED BY THE GOVERNOR, WHO MUST BE
- 20 AN ARCHITECT.
- 21 (6) FIVE MEMBERS, APPOINTED BY THE GOVERNOR, WHO MUST BE
- 22 PENNSYLVANIA VETERANS. AT LEAST ONE OF THESE MEMBERS MUST BE
- A WOMAN.
- 24 (7) THE COMMANDER OF THE PENNSYLVANIA WAR VETERAN'S
- 25 COUNCIL, OR A DESIGNEE.
- 26 (8) THE STATE ADJUTANT OF THE PENNSYLVANIA VETERANS OF
- FOREIGN WARS, OR A DESIGNEE.
- 28 (9) THE PENNSYLVANIA STATE COMMANDER OF THE DISABLED
- 29 AMERICAN VETERANS, OR A DESIGNEE.
- 30 (10) THE STATE ADJUTANT OF THE PENNSYLVANIA AMERICAN

- 1 LEGION, OR A DESIGNEE.
- 2 (11) THE ADJUTANT GENERAL OF THE DEPARTMENT OF MILITARY
- 3 AFFAIRS, OR A DESIGNEE.
- 4 (12) THE DIRECTOR OF THE BUREAU OF VETERANS AFFAIRS IN
- 5 THE DEPARTMENT OF MILITARY AFFAIRS.
- 6 (13) ONE MEMBER, APPOINTED BY THE GOVERNOR, WHO MUST BE
- 7 A CERTIFIED PUBLIC ACCOUNTANT.
- 8 (C) TERMS.--ALL MEMBERS SHALL SERVE FOR A PERIOD OF THREE
- 9 YEARS FROM THE DATE OF THEIR APPOINTMENT, EXCEPT THAT NO MEMBER
- 10 APPOINTED UNDER SUBSECTION (B)(1), (2), (3), (4), (7), (8), (9),
- 11 (10), (11) OR (12) SHALL SERVE PAST THE DATE OF EXPIRATION OF
- 12 OFFICE.
- 13 (D) VACANCIES.--VACANCIES IN THE MEMBERSHIP OF THE
- 14 COMMISSION SHALL BE FILLED IN THE SAME MANNER AS THE ORIGINAL
- 15 APPOINTMENT.
- 16 (E) ORGANIZATION AND PROCEDURE. --
- 17 (1) THE COMMISSION SHALL ELECT, BY A MAJORITY OF ALL ITS
- 18 MEMBERS, A CHAIRMAN, VICE CHAIRMAN AND A SECRETARY FROM AMONG
- 19 ITS MEMBERS, EACH TO SERVE FOR A TERM OF THREE YEARS.
- 20 (2) A MAJORITY OF ALL MEMBERS OF THE COMMISSION SHALL
- 21 CONSTITUTE A QUORUM FOR THE TRANSACTION OF BUSINESS.
- 22 (3) THE COMMISSION MAY ADOPT RULES FOR ITS GOVERNMENT,
- 23 ORGANIZATION AND PROCEDURES, NOT INCONSISTENT WITH THE
- 24 PROVISIONS OF THIS CHAPTER.
- 25 (F) EXPENSES.--COMMISSION MEMBERS SHALL RECEIVE NO
- 26 COMPENSATION FOR THEIR SERVICES BUT SHALL BE REIMBURSED BY THE
- 27 DEPARTMENT FOR ALL NECESSARY TRAVEL AND OTHER REASONABLE
- 28 EXPENSES INCURRED IN CONNECTION WITH THE PERFORMANCE OF THEIR
- 29 DUTIES AS MEMBERS OF THE COMMISSION.
- 30 (G) ADMINISTRATIVE SERVICES.--THE DEPARTMENT SHALL PROVIDE

- 1 ADMINISTRATIVE STAFF, SUPPORT AND SERVICES TO THE COMMISSION ON
- 2 AN ONGOING BASIS.
- 3 § 1904. DUTIES OF COMMISSION.
- 4 IN ADDITION TO OTHER POWERS CONFERRED BY THIS CHAPTER, THE
- 5 COMMISSION SHALL HAVE THE POWER:
- 6 (1) TO ERECT A PHYSICAL MONUMENT TO BE LOCATED ON THE
- 7 GROUNDS OF THE INDIANTOWN GAP NATIONAL CEMETERY HONORING
- 8 PENNSYLVANIA VETERANS.
- 9 (2) TO RECEIVE FOR AND ON BEHALF OF THE COMMONWEALTH
- 10 MONETARY GIFTS OR BEQUESTS WHICH SHALL BE DEPOSITED IN THE
- 11 FUND.
- 12 (3) TO ACCEPT GRANTS AND SUBSIDIES FROM AND ENTER INTO
- AGREEMENTS OR OTHER TRANSACTIONS WITH ANY FEDERAL AGENCY OR
- 14 AGENCY OF THE COMMONWEALTH OR OTHER ENTITY.
- 15 (4) TO ENTER INTO CONTRACTS AND TO EXECUTE ALL
- 16 INSTRUMENTS NECESSARY OR CONVENIENT FOR CARRYING ON ITS
- 17 OPERATIONS.
- 18 (5) TO ISSUE APPROPRIATE REGULATIONS FOR THE
- 19 IMPLEMENTATION OF THIS CHAPTER.
- 20 (6) TO DO ALL OTHER THINGS NECESSARY OR CONVENIENT TO
- 21 CARRY OUT THE POWERS GRANTED TO IT BY THIS CHAPTER.
- 22 § 1905. PENNSYLVANIA VETERANS' MEMORIAL TRUST FUND.
- 23 (A) ESTABLISHMENT AND ADMINISTRATION. -- THERE IS HEREBY
- 24 ESTABLISHED A SEPARATE FUND IN THE STATE TREASURY TO BE KNOWN AS
- 25 THE PENNSYLVANIA VETERANS' MEMORIAL TRUST FUND. THE FUND SHALL
- 26 BE ADMINISTERED BY THE COMMISSION, AND ALL MONEYS IN THE FUND
- 27 ARE APPROPRIATED TO THE COMMISSION ON A CONTINUING BASIS.
- 28 (B) PURPOSE.--THE MONEYS IN THE FUND SHALL BE USED FOR THE
- 29 SELECTION, DESIGN AND CONSTRUCTION OF AN APPROPRIATE PHYSICAL
- 30 MONUMENT ON THE GROUNDS OF THE INDIANTOWN GAP NATIONAL CEMETERY

- AND OTHER COSTS INCIDENTAL THERETO.
- 2 (C) CONTRIBUTIONS AND SOLICITATION OF FUNDS. --
- 3 (1) THE COMMISSION IS AUTHORIZED:
- 4 (I) TO ACCEPT, ON BEHALF OF THE COMMONWEALTH, GIFTS,
- 5 DONATIONS, LEGACIES AND USAGES OF MONEY FROM INDIVIDUALS,
- 6 ORGANIZATIONS, PUBLIC OR PRIVATE CORPORATIONS AND OTHER
- 7 SIMILAR ENTITIES.
- 8 (II) TO SOLICIT AND RAISE MONEYS FROM PUBLIC AND
- 9 PRIVATE SOURCES.
- (2) ALL MONEY RECEIVED OR RAISED UNDER THIS SUBSECTION 10
- 11 SHALL BE PAID INTO THE STATE TREASURY AND CREDITED TO THE
- 12 FUND.
- 13 SECTION 3. SECTION 1906 OF TITLE 51 IS REENACTED AND AMENDED
- 14 TO READ:
- 15 § 1906. EXPIRATION OF CHAPTER.
- 16 THIS CHAPTER SHALL EXPIRE JUNE 30, [1995] 1999.
- 17 Section $\frac{2}{4}$. This act shall take effect immediately.
