## A JOINT RESOLUTION

- 1 Proposing an emergency amendment to the Constitution of the
- 2 Commonwealth of Pennsylvania, further providing for special
- 3 emergency legislation.
- 4 Many Pennsylvanians have suffered greatly from the ravages of
- 5 Great Storms and Floods in recent years. The Great Storms or
- 6 Floods of 1974, 1975, 1976, 1977 and 1996 were additional major
- 7 disasters causing loss of life and great damage and destruction
- 8 to property of individuals, industrial and commercial
- 9 establishments and public facilities.
- 10 It is imperative that the victims of these disasters receive
- 11 the fullest possible aid from both the Federal Government and
- 12 the Commonwealth in order to accomplish a speedy recovery.
- 13 The Congress of the United States, through enactment of
- 14 various disaster relief laws, has authorized the making of
- 15 certain disaster relief grants. The General Assembly wishes to
- 16 make such Federal disaster relief grants, or other grants made
- 17 available from Federal programs hereafter enacted, available to

- 1 eligible individuals and families in order to alleviate the
- 2 deprivation caused by storms or floods which have occurred in
- 3 the past and seeks to address those emergencies of future years.
- 4 However, the General Assembly is limited by rigid restrictions
- 5 in the Constitution of the Commonwealth of Pennsylvania. The
- 6 safety and welfare of this Commonwealth requires the prompt
- 7 amendment to the Constitution to aid those afflicted by the
- 8 Great Storms or Floods of 1996 and any future emergency that may
- 9 strike Commonwealth citizens.
- 10 The General Assembly of the Commonwealth of Pennsylvania
- 11 hereby resolves as follows:
- 12 Section 1. The following amendment to the Constitution of
- 13 Pennsylvania is proposed in accordance with the emergency
- 14 provisions of Article XI:
- 15 That section 17 of Article VIII be amended to read:
- 16 § 17. Special emergency legislation.
- 17 (a) Notwithstanding any provisions of this Constitution to
- 18 the contrary, the General Assembly shall have the authority to
- 19 enact laws providing for tax rebates, credits, exemptions,
- 20 grants-in-aid, State supplementations, or otherwise provide
- 21 special provisions for individuals, corporations, associations
- 22 or nonprofit institutions, including nonpublic schools (whether
- 23 sectarian or nonsectarian) in order to alleviate the danger,
- 24 damage, suffering or hardship faced by such individuals,
- 25 corporations, associations, institutions or nonpublic schools as
- 26 a result of [Great Storms or Floods of September 1971, of June
- 27 1972, or of 1974, or of 1975, or of 1976] <u>natural disasters</u>.
- 28 (b) Notwithstanding the provisions of Article III, section
- 29 29 subsequent to a Presidential declaration of an emergency or
- 30 of a major disaster in any part of this Commonwealth, the

- 1 General Assembly shall have the authority by a vote of two-
- 2 thirds of all members elected to each House to make
- 3 appropriations limited to moneys required for Federal emergency
- 4 or major disaster relief. This subsection may apply
- 5 retroactively to any Presidential declaration of an emergency or
- 6 of a major disaster [in 1976 or 1977].
- 7 Section 2. (a) The General Assembly hereby determines that
- 8 a major emergency threatens or is about to threaten this
- 9 Commonwealth and that the safety or welfare of this Commonwealth
- 10 requires prompt amendment of the Constitution of Pennsylvania by
- 11 this constitutional amendment.
- 12 (b) Upon passage by the General Assembly of this proposed
- 13 constitutional amendment, the Secretary of the Commonwealth
- 14 shall proceed immediately to comply with the advertising
- 15 requirements of section 1(a) of Article XI of the Constitution
- 16 of Pennsylvania and shall transmit the required advertisements
- 17 to two newspapers in every county in which such newspapers are
- 18 published in sufficient time after passage of this proposed
- 19 constitutional amendment. The Secretary of the Commonwealth
- 20 shall submit this proposed constitutional amendment to the
- 21 qualified electors of this Commonwealth at the first primary,
- 22 general or municipal election occurring at least one month after
- 23 the proposed constitutional amendment is passed by the General
- 24 Assembly which meets the requirements of and is in conformance
- 25 with section 1(a) of Article XI of the Constitution of
- 26 Pennsylvania.
