AN ACT

- Amending the act of June 11, 1947 (P.L.565, No.248), entitled "An act providing compensation to certain persons who served 3 in the military or naval forces of the United States or of any of her allies during World War II; providing the method of making payment to representatives of persons who, because of death or incapacity, cannot personally receive 7 compensation; imposing certain duties on the Adjutant General; making an appropriation, and providing penalties," 9 extending the time during which applications may be filed for veterans' compensation; and making an appropriation. 10 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. Section 5 of the act of June 11, 1947 (P.L.565,
- 14 No.248), known as the World War II Veterans' Compensation Act,
- 15 amended June 14, 1961 (P.L.370, No.203), is amended to read:
- 16 Section 5. Application for Compensation .-- Application for
- 17 compensation shall be made to the Adjutant General on such forms
- 18 and in such manner as he shall prescribe.
- 19 Applicants shall state on their application whether or not

- 1 they have applied for or received a bonus, gratuity or
- 2 compensation, of a nature similar to that provided for by this
- 3 act, from any other state in the Union.
- 4 All applications shall be made, (1) personally by the
- 5 veteran, or (2) in case of death or mental incompetency
- 6 preventing the making of a personal application, then by such
- 7 representative of the veteran as the Adjutant General shall by
- 8 regulation prescribe. An application made by a representative
- 9 other than one authorized by such regulation shall be held void.
- 10 The Adjutant General shall not accept or consider any
- 11 application filed with him after the thirty-first day of
- 12 December, one thousand nine hundred [sixty-two.] ninety-seven.
- 13 Section 2. The sum of \$500,000, or as much thereof as may be
- 14 necessary, is hereby appropriated to the World War II Veterans'
- 15 Compensation Fund to carry out the purposes of the act.
- 16 Section 3. This act shall take effect immediately.
