A RESOLUTION

- Directing the Urban Affairs Committee, in cooperation with the Military and Veterans Affairs Committee, to conduct a study on the feasibility of using airship technology to assist
- 4 police agencies to combat crime.
- 5 WHEREAS, Crime is a major problem facing this Commonwealth's
- 6 municipalities, especially in its urban areas; and
- WHEREAS, To effectively combat crime, it is important that
- 8 State and local police have the latest technology available; and
- 9 WHEREAS, In addition to crime surveillance, the innovative
- 10 use of airship technology has the potential of assisting police
- 11 agencies in this Commonwealth with disaster control, aerial
- 12 searches, traffic control and monitoring, police training and
- 13 many other police and fire activities related to public safety;
- 14 and
- 15 WHEREAS, Airships are also capable of performing a variety of
- 16 nonpolice and nonpublic safety-related activities of value to
- 17 this Commonwealth's municipalities, universities and State
- 18 agencies, including, but not limited to, environmental and

- 1 scientific research, traffic and planning studies and aerial
- 2 photography; therefore be it
- 3 RESOLVED, That the House of Representatives direct the Urban
- 4 Affairs Committee, in cooperation with the Military and Veterans
- 5 Affairs Committee, to conduct a thorough study of the
- 6 feasibility of using airship technology to assist State and
- 7 local police agencies in this Commonwealth to combat crime; and
- 8 be it further
- 9 RESOLVED, That the study:
- 10 (1) review how airship technology might assist existing
- 11 State agencies and universities in the performance of their
- 12 State-mandated duties and responsibilities;
- 13 (2) review how airship technology might assist elected
- municipal officials in this Commonwealth, especially in the
- larger urban centers, including Pittsburgh and Philadelphia,
- in the performance of their mandated duties and
- 17 responsibilities in areas, including, but not limited to,
- 18 public safety;
- 19 (3) review any legal impediments to the use of airship
- 20 technology in this Commonwealth;
- 21 (4) estimate the cost to the Commonwealth to provide
- 22 airship service by purchase, lease or a combination thereof
- 23 for State and municipal activities and uses which may be
- deemed valid and feasible by the study;
- 25 (5) include recommendations concerning the feasibility
- of the joint usage of airship services, if available, by
- 27 State agencies, universities, municipalities and neighboring
- 28 states;
- 29 (6) consider the need for a demonstration project to
- 30 validate the usefulness of airship technology for all State

- and local uses the Urban Affairs Committee and the Military
- 2 and Veterans Affairs Committee conclude may be feasible;
- 3 (7) estimate the cost of such a demonstration project
- 4 and the availability of Federal, State and private sector
- financial resources to fund the study; and
- 6 (8) contract for and supervise a demonstration project
- 7 if adequate funding is available;
- 8 and be it further
- 9 RESOLVED, That the Urban Affairs Committee report its
- 10 findings to the House of Representatives as soon as possible.
