AN ACT

- 1 Providing for licensing for motor vehicle dealers who make
- 2 certain warranties; imposing penalties; and conferring powers
- 3 and duties upon the Insurance Department.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Automobile
- 8 Dealers Warranty Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- "Dealer." A person in the business of selling or exchanging
- 14 motor vehicles.
- 15 "Dealer's warranty." Any of the following:
- 16 (1) A warranty on a used motor vehicle offered for sale
- 17 by a dealer.
- 18 (2) A warranty which exceeds the manufacturer's express

- 1 warranty.
- 2 "Department." The Insurance Department of the Commonwealth.
- 3 "Manufacturer." A person engaged in the business of:
- 4 (1) constructing or assembling new and unused motor
- 5 vehicles; or
- 6 (2) importing new and unused motor vehicles into the
- 7 United States for the purpose of selling them to dealers in
- 8 this Commonwealth.
- 9 "Manufacturer's express warranty." The written warranty of
- 10 the manufacturer for a motor vehicle constructed, assembled or
- 11 imported by the manufacturer as to condition and fitness for
- 12 use. The term includes conditions precedent to the obligations
- 13 of the warranty.
- 14 "Motor vehicle." As defined in 75 Pa.C.S. § 102 (relating to
- 15 definitions).
- 16 Section 3. Prohibition.
- 17 (a) General rule.--A dealer may not make a dealer's warranty
- 18 without a license from the department under section 4.
- 19 (b) Penalty.--A person who violates this section commits a
- 20 summary offense and shall, upon conviction, be sentenced to pay
- 21 a fine of \$1,000.
- 22 Section 4. License.
- 23 (a) Application. -- A dealer may apply to the department for a
- 24 license to make dealer's warranties.
- 25 (b) Qualifications.--A dealer is eligible for licensure if
- 26 the dealer demonstrates to the satisfaction of the department
- 27 financial responsibility to fulfill the obligations of the
- 28 warranty.
- 29 Section 5. Department.
- The department has the following powers and duties:

- 1 (1) To administer this act.
- 2 (2) To promulgate regulations to implement this act.
- 3 (3) To assist in criminal prosecutions under section
- 4 3(b).
- 5 Section 6. Applicability.
- 6 This act shall apply only to dealer's warranties made on or
- 7 after the effective date of this section.
- 8 Section 7. Effective date.
- 9 This act shall take effect as follows:
- 10 (1) Section 5(2) and this section shall take effect
- immediately.
- 12 (2) The remainder of this act shall take effect on the
- effective date of the regulations promulgated under section
- 14 5(2).
