A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- 2 of Pennsylvania, providing for a maximum number of
- 3 consecutive terms of office for members of the General
- 4 Assembly.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby resolves as follows:
- 7 Section 1. The following amendment to the Constitution of
- 8 Pennsylvania is proposed in accordance with Article XI:
- 9 That section 3 of Article II be amended to read:
- 10 § 3. Terms of members.
- 11 (a) Senators shall be elected for the term of four years and
- 12 Representatives for the term of two years. Senators shall not be
- 13 eligible for election to more than three consecutive terms of
- 14 office in the Senate. Representatives shall not be eliqible for

- 1 election to more than six consecutive terms of office in the
- 2 House of Representatives.
- 3 (b) A Senator who has served the maximum number of
- 4 consecutive terms of office in the Senate may become a candidate
- 5 for election to the Senate at an election held not fewer than
- 6 three years after completion of the Senator's third consecutive
- 7 term of office. A Representative who has served the maximum
- 8 number of consecutive terms of office in the House of
- 9 Representatives may become a candidate for election to the House
- 10 of Representatives at an election held not less than one year
- 11 after completion of the Representative's sixth consecutive term
- 12 of office.
- (c) Service in the General Assembly performed prior to
- 14 December 1, 2000, shall not be considered in determining the
- 15 maximum number of consecutive terms a Senator or Representative
- 16 may serve or in determining eligibility of a Senator or
- 17 Representative for election.
- 18 (d) For persons elected to a term of office in the Senate in
- 19 an election held in any year after the year 1997 and said term
- 20 of office ends on November 30, 2002, service in the Senate
- 21 performed prior to December 1, 2002, shall not be considered in
- 22 determining the maximum number of consecutive terms such a
- 23 person may serve or in determining eligibility of such a person
- 24 for election.
- 25 Section 2. (a) Upon the first passage by the General
- 26 Assembly of this proposed constitutional amendment, the
- 27 Secretary of the Commonwealth shall proceed immediately to
- 28 comply with the advertising requirements of section 1 of Article
- 29 XI of the Constitution of Pennsylvania and shall transmit the
- 30 required advertisements to two newspapers in every county in

- 1 which such newspapers are published in sufficient time after
- 2 passage of this proposed constitutional amendment.
- 3 (b) Upon the second passage by the General Assembly of this
- 4 proposed constitutional amendment, the Secretary of the
- 5 Commonwealth shall proceed immediately to comply with the
- 6 advertising requirements of section 1 of Article XI of the
- 7 Constitution of Pennsylvania and shall transmit the required
- 8 advertisements to two newspapers in every county in which such
- 9 newspapers are published in sufficient time after passage of
- 10 this proposed constitutional amendment. The Secretary of the
- 11 Commonwealth shall submit this proposed constitutional amendment
- 12 to the qualified electors of this Commonwealth at the first
- 13 primary, general or municipal election occurring at least three
- 14 months after the proposed constitutional amendment is passed by
- 15 the General Assembly which meets the requirements of and is in
- 16 conformance with section 1 of Article XI of the Constitution of
- 17 Pennsylvania.
