- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
 - Pennsylvania Consolidated Statutes, further providing for
- 3 governmental immunity relating to computer errors.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:

- 6 Section 1. Title 42 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a heading and a section to read:
- 8 TECHNOLOGICAL IMMUNITY
- 9 § 8531. Immunity for certain erroneous computer information.
- 10 (a) General rule. -- No cause of action, including, but not
- 11 limited to, any civil action or action for declaratory
- 12 injunctive relief, may be brought against an immune contractor
- 13 or an officer or employee of the Commonwealth or any of its
- 14 agencies or political subdivisions on the basis that a computer
- 15 or other information system that is owned or operated by any of
- 16 those persons produced, calculated or generated an incorrect

- 1 date, regardless of the cause of the error.
- 2 (b) Contract requirement. -- Any contract entered into by or
- 3 on behalf of and in the capacity of the Commonwealth, an immune
- 4 contractor or an officer or employee of the Commonwealth or any
- 5 of its agencies or political subdivisions shall include a
- 6 provision that provides immunity to those persons for any breach
- 7 of contract that is caused by an incorrect date being produced,
- 8 <u>calculated or generated by a computer or other information</u>
- 9 system that is owned or operated by any of those persons,
- 10 regardless of the cause of the error.
- 11 (c) Applicability. -- Any contract subject to the provisions
- 12 of this section that is entered into or on or after June 30,
- 13 1998, shall be granted the immunity provided for by this section
- 14 and any provision of a contract which is in conflict with this
- 15 section is void.
- 16 (D) DEFINITION.--AS USED IN THIS SECTION, THE TERM "IMMUNE <-
- 17 CONTRACTOR" SHALL INCLUDE ANY ENTITY EITHER APPOINTED BY OR IN A
- 18 CONTRACTUAL RELATIONSHIP WITH THE COMMONWEALTH OR ANY OF ITS
- 19 POLITICAL SUBDIVISIONS TO PERFORM A GOVERNMENTAL DUTY OR
- 20 FUNCTION, WHETHER MINISTERIAL IN NATURE OR OTHERWISE.
- 21 (d) (E) Expiration.--This section shall expire December 30, <--
- 22 2005.
- 23 Section 2. This act shall take effect immediately.
