AN ACT

- 1 Providing for the reporting of crimes of violence committed on
- 2 the grounds of school entities.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the School
- 7 Violence Mandatory Reporting Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Crime of violence." Murder or any criminal homicide,
- 13 aggravated assault, simple assault, rape, involuntary deviate
- 14 sexual intercourse, arson, kidnapping, robbery, terroristic
- 15 threats, harassment, stalking, possession of a weapon on school
- 16 property, possession of an offensive weapon, possession of an
- 17 instrument of crime or robbery of a motor vehicle or criminal

- 1 attempt, criminal conspiracy or criminal solicitation to commit
- 2 any of the offenses listed above.
- 3 "Law enforcement agency." The Pennsylvania State Police, the
- 4 district attorney of the county in which the school is located
- 5 and the police department with primary jurisdiction over the
- 6 area in which the school grounds or property is located or where
- 7 the crime of violence is alleged to have occurred.
- 8 Section 3. Required reporting.
- 9 (a) General rule.--Each principal, dean or other person who
- 10 acts as the chief operating or executive officer of a public,
- 11 private, parochial, vocational or charter school, including, but
- 12 not limited to, a college or university shall make an incident
- 13 report to a law enforcement agency, within 48 hours of the
- 14 incident, on a form prescribed by the Pennsylvania State Police,
- 15 concerning all incidents of a crime of violence which occur on
- 16 the property or grounds of the school, college or university.
- 17 (b) Contents of report.--The incident report shall include
- 18 the following:
- 19 (1) Names, addresses and telephone numbers of the victim
- or victims, the accused and any witnesses.
- 21 (2) Names, addresses and telephone numbers of the
- 22 parents or quardians of any minors involved as a victim,
- accused or witness to the incident.
- 24 (3) A narrative for the incident, including the date,
- 25 time and circumstances of the incident.
- 26 (4) What, if any, weapons were used or threatened to be
- used.
- 28 (5) A description of any injuries.
- 29 (6) A description of any evidence that would tend to
- 30 establish that a crime of violence was committed.

- 1 (7) An indication of whether law enforcement was
- 2 contacted and whether an arrest was or was not made.
- 3 (8) If an arrest was made, the crimes with which the
- 4 accused was charged.
- 5 (c) Information concerning crimes of violence. -- Each law
- 6 enforcement agency and the Pennsylvania State Police shall
- 7 transmit to the Pennsylvania State Police in a uniform manner
- 8 prescribed by the Pennsylvania State Police, the information
- 9 specified in subsection (b) related to crimes of violence on
- 10 school grounds or property.
- 11 (d) Annual report. -- The Pennsylvania State Police shall
- 12 annually compile and analyze the incident report data received
- 13 and publish a Statewide report concerning crimes of violence on
- 14 school property and grounds. The Pennsylvania State Police shall
- 15 transmit a copy of the annual report to the Governor and to the
- 16 General Assembly.
- 17 Section 4. Repeal.
- 18 The provisions of 18 Pa.C.S. Ch. 91 are repealed insofar as
- 19 they are inconsistent with this act.
- 20 Section 5. Effective date.
- 21 This act shall take effect in 60 days.
