AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, providing for police animals; and
- 3 providing penalties.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 18 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 5511.2. Police animals.
- 9 (a) Illegal to taunt police animals. -- It shall be unlawful
- 10 for any person to willfully or maliciously taunt, torment,
- 11 tease, beat, kick or strike a police animal. Any person who
- 12 violates any of the provisions of this subsection commits a
- 13 felony of the third degree.
- (b) Illegal to torture police animals. -- It shall be unlawful
- 15 for any person to willfully or maliciously torture, mutilate,
- 16 injure, disable, poison or kill a police animal. Any person who

- 1 violates any of the provisions of this subsection commits a
- 2 <u>felony of the third degree</u>.
- 3 (c) Restitution.--In any case in which a defendant is
- 4 convicted of a violation of subsection (a) or (b), the defendant
- 5 shall be ordered to make restitution to the agency or individual
- 6 owning the animal for any veterinary bills, for replacement
- 7 costs of the animal if it is disabled or killed and for the
- 8 salary of the animal's handler for the period of time the
- 9 <u>handler's services are lost to the agency.</u>
- 10 (d) Definitions. -- As used in this section, the following
- 11 words and phrases shall have the meanings given to them in this
- 12 <u>subsection</u>:
- 13 <u>"Accelerant detection dog." A dog which is trained for</u>
- 14 accelerant detection, commonly referred to as arson canines.
- 15 "Bomb detection dog." A dog which is trained to locate a
- 16 <u>bomb or explosives by scent.</u>
- 17 "Narcotic detection dog." A dog which is trained to locate
- 18 narcotics by scent.
- 19 "Police animal." An animal, including, but not limited to,
- 20 dogs and horses, used by the Pennsylvania State Police, the
- 21 Department of Corrections, a county correctional facility OR
- 22 OFFICE or by a municipal police department, fire department,
- 23 search and rescue unit or agency or handler under the
- 24 <u>supervision of such department</u>, <u>search and rescue unit or agency</u>
- 25 in the performance of the functions or duties of such
- 26 <u>department</u>, <u>search</u> and <u>rescue</u> unit or <u>agency</u>, <u>whether</u> the <u>animal</u>
- 27 is on duty or not on duty. The term shall include, but not be
- 28 limited to, an accelerant detection dog, bomb detection dog,
- 29 narcotic detection dog, search and rescue dog and tracking
- 30 animal.

- 1 <u>"Search and rescue dog." A dog which is trained to locate</u>
- 2 <u>lost or missing persons, victims of natural or manmade disasters</u>
- 3 <u>and human bodies.</u>
- 4 "Tracking animal." An animal which is trained to track or
- 5 <u>used to pursue a missing person, escaped inmate or fleeing</u>
- 6 <u>felon</u>.
- Section 2. This act shall take effect in 60 days. 7
