AN ACT

Amending the act of May 5, 1999 (P.L. , No.1A), entitled "An act to provide from the General Fund for the expenses of the 2 3 Executive, Legislative and Judicial Departments of the 4 Commonwealth, the public debt and for the public schools for the fiscal year July 1, 1999, to June 30, 2000, for certain 6 institutions and organizations, and for the payment of bills 7 incurred and remaining unpaid at the close of the fiscal year 8 ending June 30, 1999; to provide appropriations from the 9 State Lottery Fund, the Energy Conservation and Assistance Fund, the Hazardous Material Response Fund, The State Stores 10 Fund, the Milk Marketing Fund, the Home Investment Trust 11 12 Fund, the Emergency Medical Services Operating Fund, the Ben 13 Franklin/IRC Partnership Fund, the Tuition Payment Fund, the Banking Department Fund and the Firearm Records Check Fund to 14 15 the Executive Department; and to provide appropriations from 16 the Judicial Computer System Augmentation Account to the 17 Judicial Department for the fiscal year July 1, 1999, to June 18 30, 2000; and to provide appropriations from the Motor License Fund for the fiscal year July 1, 1999, to June 30, 19 20 2000, for the proper operation of the several departments of the Commonwealth and the Pennsylvania State Police authorized 21 to spend Motor License Fund moneys; to provide for the 22 23 appropriation of Federal funds to the Executive and Judicial 24 Departments of the Commonwealth and for the establishment of restricted receipt accounts for the fiscal year July 1, 1999, 25 26 to June 30, 2000, and for the payment of bills remaining 27 unpaid at the close of the fiscal year ending June 30, 1999; 28 and to provide for the additional appropriation of Federal 29 and State funds for the Executive Department of the 30 Commonwealth for the fiscal year July 1, 1998, to June 30, 31 1999, and for the payment of bills incurred and remaining 32 unpaid at the close of the fiscal year ending June 30, 1998," 33 further providing for textbooks and instructional material
