## A RESOLUTION

1	To honor the volunteers of Lutheran Brotherhood in Pennsylvania.
2	WHEREAS, Lutheran Brotherhood was founded in 1917 and
3	formally chartered November 18, 1918; and
4	WHEREAS, Lutheran Brotherhood is a member-owned fraternal
5	benefit society of 1.1 million Lutherans joined together for
б	financial security, benevolent outreach and volunteer service;

8	WHEREAS, Lutheran Brotherhood's family of financial services
9	for Lutherans has included life and health insurance, annuities,
10	investment products and a variety of custom services; and
11	WHEREAS, With more than \$22 billion in assets under
12	management, Lutheran Brotherhood is among the largest of the

1 fraternal benefit societies; and

WHEREAS, In 1998 Lutheran Brotherhood allocated \$66 million 2 3 nationally for fraternal programs and activities in support of its members, congregations, Lutheran institutions and 4 communities and allocated more than \$3 million in resources to 5 outreach programs in this Commonwealth; and 6 7 WHEREAS, Nationwide, Lutheran Brotherhood members and volunteers participated in 31,260 events and activities totaling 8 10.1 million hours of volunteerism, 3.1 million of which were 9 10 devoted to community service projects; and WHEREAS, In Pennsylvania, 74 Lutheran Brotherhood branches or 11 geographic volunteer groups contributed 573,554 hours of 12 13 volunteerism, 250,171 of which were devoted to community service projects; and 14 15 WHEREAS, Volunteers completed projects which included 16 purchasing and distributing food to local food banks, contributing material and manpower for Habitat for Humanity and 17 18 generating funds for local and national disaster relief efforts; 19 and 20 WHEREAS, The North Lehigh Branch No. 8629 was honored by 21 Pennsylvanians With Disabilities in January 1998 for its efforts 22 in designing and constructing wheelchair ramps for local needy 23 families; therefore be it RESOLVED, That the House of Representatives commend the many 24 25 volunteers of Lutheran Brotherhood for their untiring efforts and selfless service to the citizens of this Commonwealth and 26
