AN ACT

- 1 Authorizing the Department of Community and Economic Development
- 2 to adopt a program of training, examination and continuing
- 3 education of elected auditors.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Elected
- 8 Auditors' Training Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Auditor." A person duly elected to, or appointed to fill a
- 14 vacancy in the position of elected auditor under any of the
- 15 following:
- 16 (1) Act of June 24, 1931 (P.L.1206, No.331), known as
- 17 The First Class Township Code.

- 1 (2) Act of May 1, 1933 (P.L.103, No.69), known as The
- 2 Second Class Township Code.
- 3 (3) Act of August 9, 1955 (P.L.323, No.130), known as
- 4 The County Code.
- 5 (4) Act of February 1, 1966 (1965 P.L.1656, No.581),
- 6 known as The Borough Code.
- 7 (5) 53 Pa.C.S. Pt. III Subpt. E (relating to home rule
- 8 and optional plan government).
- 9 "Certificate." Documentation of successful completion of the
- 10 basic training program and the continuing education program.
- 11 "Department." The Department of Community and Economic
- 12 Development of the Commonwealth.
- 13 Section 3. Educational programs for auditors.
- 14 (a) Basic training. -- The department, in consultation with
- 15 the Auditor General, the Pennsylvania Institute of Certified
- 16 Public Accountants, the Pennsylvania Society of Public
- 17 Accountants and the Pennsylvania State Association of County
- 18 Auditors shall adopt and implement a program of basic training
- 19 and examination for auditors of this Commonwealth. The
- 20 department may contract with a third party to provide such
- 21 training and examination.
- 22 (b) Continuing education.--The department, in consultation
- 23 with the Auditor General, the Pennsylvania Institute of
- 24 Certified Public Accountants, the Pennsylvania Society of Public
- 25 Accountants and the Pennsylvania State Association of County
- 26 Auditors, shall adopt and implement a program of continuing
- 27 education and examination for auditors of this Commonwealth. The
- 28 department may contract with a third party to provide such
- 29 education and examination.
- 30 Section 4. Program guidelines.

- 1 (a) Courses. -- The basic training and continuing education
- 2 programs shall include, but not be limited to, the following
- 3 courses:
- 4 (1) Duties and responsibilities of auditors.
- 5 (2) The code requirements and other statutes related to
- 6 the office of auditor.
- 7 (3) Budget process.
- 8 (4) Accounting.
- 9 (5) Ethics.
- 10 (6) Planning the audit.
- 11 (7) Audit procedures.
- 12 (8) Financial reporting.
- 13 (b) Prerequisites.--
- 14 (1) As a prerequisite to taking an examination, the
- individual shall complete the basic training program
- 16 authorized by the department.
- 17 (2) As a prerequisite for taking any continuing
- 18 education courses for the purpose of meeting continuing
- 19 education requirements set forth under this act, an
- 20 individual must complete the basic training program
- 21 authorized by the department.
- 22 (c) Examinations.--
- 23 (1) An individual shall have the option to sit for the
- 24 examination approved by the department relating to the basic
- 25 education program.
- 26 (2) An individual who passes the basic training
- 27 examination shall be known as a "Trained Municipal Auditor."
- 28 Section 5. Renewal of training title.
- 29 Renewal of basic training shall occur biennially upon
- 30 completion of a continuing education program authorized by the

- 1 department.
- 2 Section 6. Department duties.
- 3 The department shall:
- 4 (1) Notify current trained municipal auditors of the
- 5 continuing education requirements prior to any deadline for
- 6 renewal of title.
- 7 (2) Maintain a register that lists all trained municipal
- 8 auditors. The register shall be open to public inspection.
- 9 (3) Provide copies of the register to the public upon
- 10 payment of a nominal fee.
- 11 (4) Determine and approve reasonable fees for training
- and continuing education programs and for testing and
- titling. The individual shall bear the cost of the program,
- 14 testing and titling, unless the municipality agrees to pay
- 15 for the cost in whole or in part.
- 16 Section 7. Unlawful activity.
- 17 It shall be unlawful, on or after the effective date of this
- 18 act, for any individual to hold himself or herself out as being
- 19 trained under this act unless the individual holds a current,
- 20 valid trained municipal auditor certificate.
- 21 Section 8. Participation in programs.
- 22 (a) General rule. -- Nothing in this act shall prevent any
- 23 individual from participating in the department's training and
- 24 continuing education programs and from obtaining the title of
- 25 "Trained Municipal Auditor."
- 26 (b) Nature of participation. -- Participation in the training,
- 27 examination and continuing education under this act is
- 28 voluntary. Failure to participate, to complete or to take the
- 29 examination shall not disqualify a person from holding office or
- 30 from performing that person's official duties.

- 1 Section 9. Effective date.
- 2 This act shall take effect in 60 days.
