- 10 DEAL WITH THOSE PROBLEMS AND CAUSES; AND ESTABLISHING
- 11 PRIORITIES AMONG PROJECTS, ACTIVITIES AND AREAS AS NEEDED FOR
- 12 THE BEST AND MOST EFFICIENT USE OF RESOURCES.
- 13 (2) ENCOURAGING AGENCIES ENGAGED IN ACTIVITIES RELATED
- 14 TO THE COMMUNITY ACTION PROGRAM TO PLAN FOR, SECURE AND
- 15 ADMINISTER ASSISTANCE AVAILABLE UNDER THIS ACT OR FROM OTHER
- 16 SOURCES ON A COMMON OR COOPERATIVE BASIS; PROVIDING PLANNING
- 17 OR TECHNICAL ASSISTANCE TO THOSE AGENCIES; AND GENERALLY, IN
- 18 COOPERATION WITH COMMUNITY AGENCIES AND OFFICIALS,

- 17 (A) NOTICE OF DISCREPANCY OR VIOLATION. -- IF A DISCREPANCY OR
- 18 VIOLATION OF THIS ACT IS DISCOVERED THROUGH MONITORING AND
- 19 AUDITING ACTIVITIES OF THE DEPARTMENT, THE DEPARTMENT SHALL
- 20 NOTIFY THE COMMUNITY ACTION AGENCY OF THE DISCREPANCY OR
- 21 VIOLATION IMMEDIATELY BY CERTIFIED MAIL.
- 22 (B) AGENCY RESPONSE. -- THE AGENCY SHALL RESPOND TO THE
