- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain 3 provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto, " providing an incentive program to
- increase enrollment at area vocational-technical schools; and
- 7 making an appropriation.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 10 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- as the Public School Code of 1949, is amended by adding a 11
- 12 section to read:
- 13 Section 2595.1. Area Vocational-Technical School Enrollment
- 14 Incentive Program. -- (a) Any school district that sponsors an
- 15 area vocational-technical school is eligible to participate in

1 the enrollment incentive program. 2 (b) Incentives shall be provided annually to A school 3 districts which sponsor area vocational technical schools and <---4 which meet or exceed their enrollment goals as those enrollment 5 goals are established in the area vocational technical schools' articles of agreement. Payment of enrollment incentive funds to 6 7 school districts that meet or exceed their enrollment goals shall be based on a school district's increase in student 8 9 DISTRICT WHICH SPONSORS AN AREA VOCATIONAL-TECHNICAL SCHOOL AND 10 WHICH MEETS, EXCEEDS OR MAINTAINS ITS ENROLLMENT GOAL AS THAT 11 ENROLLMENT GOAL IS ESTABLISHED IN THE AREA VOCATIONAL-TECHNICAL 12 SCHOOL'S ARTICLES OF AGREEMENT. PAYMENT OF ENROLLMENT INCENTIVE 13 FUNDS OR ENROLLMENT MAINTENANCE FUNDS TO A SCHOOL DISTRICT THAT 14 MEETS, EXCEEDS OR MAINTAINS ITS ENROLLMENT GOAL SHALL BE BASED 15 ON THE SCHOOL DISTRICT'S INCREASE IN OR MAINTENANCE OF ITS 16 STUDENT enrollment. For the purposes of this section, enrollment 17 qoals AN ENROLLMENT GOAL shall be enrollment qoals THE <----18 ENROLLMENT GOAL in effect in the year prior to the year in which 19 the enrollment incentive is paid. 20 (c) Any school district may apply to the Department of 21 Education for enrollment incentive funds OR ENROLLMENT <---22 MAINTENANCE FUNDS under this section by submitting data showing 23 that the school district has met or, exceeded OR MAINTAINED its 24 enrollment goal. Data showing that the school district has met 25 or exceeded, EXCEEDED OR MAINTAINED its enrollment goal must <---26 compare the school district's enrollment in an area vocational-27 technical school in the year prior to the year for which 28 enrollment incentives are paid to the school district's 29 enrollment in an area vocational-technical school in the year 30 for which enrollment incentives are paid.

- 1 (d) For purposes of this section, a school district shall be
- 2 eliqible for enrollment incentive funds under the following
- 3 circumstances:
- 4 (1) Where a school district's enrollment data shows that the
- 5 school district has met its enrollment goal, the increase in
- 6 student enrollment shall be equal to the difference between the
- 7 school district's enrollment goal and the school district's
- 8 <u>actual enrollment in an area vocational-technical school in the</u>
- 9 year prior to the year for which the enrollment incentive is
- 10 paid.
- 11 (2) Where a school district's enrollment data shows that the
- 12 school district has exceeded its enrollment goal, the increase
- 13 <u>in student enrollment shall be equal to the difference between</u>
- 14 the school district's actual enrollment in the area vocational-
- 15 technical school and the school district's enrollment in the
- 16 area vocational-technical school in the year prior to the year

- 17 for which the enrollment incentive is paid. WHERE A SCHOOL
- 18 DISTRICT'S ENROLLMENT DATA SHOWS THAT THE SCHOOL DISTRICT HAS
- 19 MAINTAINED ITS ENROLLMENT GOAL, THE SCHOOL DISTRICT'S ACTUAL
- 20 ENROLLMENT FOR THE YEAR FOR WHICH THE ENROLLMENT IS PAID:
- 21 (I) IS AT LEAST EQUAL TO THE ACTUAL ENROLLMENT FOR THE YEAR
- 22 PRIOR TO WHICH THE ENROLLMENT INCENTIVE IS PAID; AND
- 23 (II) MEETS OR EXCEEDS THE ENROLLMENT GOAL FOR THE YEAR FOR
- 24 WHICH THE ENROLLMENT INCENTIVE IS PAID AND MEETS OR EXCEEDS THE
- 25 ENROLLMENT GOAL FOR THE YEAR PRIOR TO THE YEAR FOR WHICH
- 26 ENROLLMENT INCENTIVE IS PAID.
- 27 (e) (1) The Secretary of Education shall award a school
- 28 <u>district that applies for enrollment incentive funds under</u>
- 29 <u>subsection (c) and meets or exceeds its enrollment goal an</u>
- 30 <u>amount determined by multiplying the increase in student</u>

- 1 enrollment as determined by subsection (d) by a fixed amount per
- 2 <u>student established annually when the appropriation for the area</u>
- 3 <u>vocational-technical school enrollment incentive program is</u>
- 4 <u>established. The fixed amount per student shall not exceed two</u>
- 5 thousand dollars (\$2,000).
- 6 (2) THE SECRETARY OF EDUCATION SHALL AWARD A SCHOOL DISTRICT <-
- 7 THAT APPLIES FOR ENROLLMENT MAINTENANCE FUNDS UNDER SUBSECTION
- 8 (C) AND MEETS ITS ENROLLMENT GOALS IN THE YEAR FOR WHICH THE
- 9 ENROLLMENT INCENTIVE IS PAID AND FOR THE YEAR PRIOR TO THE YEAR
- 10 FOR WHICH ENROLLMENT INCENTIVE IS PAID, AND HAS AN ACTUAL
- 11 ENROLLMENT AT LEAST EQUAL TO THE ACTUAL ENROLLMENT OF THE YEAR
- 12 PRIOR TO THE YEAR FOR WHICH THE ENROLLMENT INCENTIVE IS PAID, AN
- 13 ENROLLMENT MAINTENANCE PAYMENT OF TEN THOUSAND DOLLARS
- 14 (\$10,000).
- (f) Enrollment incentive funds shall be paid only to school
- 16 <u>districts that qualify pursuant to subsection (b).</u>
- 17 Section 2. The sum of \$10,000,000, or as much thereof as may
- 18 be necessary, is hereby appropriated to the Department of
- 19 Education for the fiscal year July 1, 2001, to June 30, 2002,
- 20 for purposes of enrollment incentive payments for area
- 21 vocational-technical schools.
- 22 Section 3. This act shall take effect July 1, 2001.
