## AN ACT

- Amending the act of July 19, 1979 (P.L.130, No.48), entitled "An act relating to health care; prescribing the powers and duties of the Department of Health; establishing and 3 providing the powers and duties of the State Health 5 Coordinating Council, health systems agencies and Health Care Policy Board in the Department of Health, and State Health 6 7 Facility Hearing Board in the Department of Justice;
- providing for certification of need of health care providers 9 and prescribing penalties, "providing for anesthesia services.

- The General Assembly of the Commonwealth of Pennsylvania 11
- 12 hereby enacts as follows:
- 13 Section 1. The act of July 19, 1979 (P.L.130, No.48), known
- 14 as the Health Care Facilities Act, is amended by adding a
- 15 section to read:
- 16 Section 203. Anesthesia services.
- (A) GENERAL RULE. -- Anesthesia shall be provided by a 17

- 1 qualified physician, anesthesiologist, resident physician in
- 2 training, dentist anesthetist, qualified nurse anesthetist or a
- 3 <u>supervised nurse trainee enrolled in a course approved by the</u>
- 4 American Association of Nurse Anesthetists. Anesthesia shall be
- 5 <u>administered in accordance with department regulations, which</u>
- 6 shall include the requirement that anesthesia be administered
- 7 under the supervision of the operating physician or
- 8 <u>anesthesiologist who is physically present in the health care</u>
- 9 <u>facility when the anesthesia is administered</u>.
- 10 (B) LIMITATION OF SUBSECTION (A).--SUBSECTION (A) DOES NOT
- 11 REQUIRE THE PHYSICAL PRESENCE OF AN ANESTHESIOLOGIST IN AN
- 12 <u>AMBULATORY SURGICAL FACILITY.</u>
- (C) LIMITATION OF SUBSECTION (A).--SUBSECTION (A) DOES NOT
- 14 PROHIBIT A HEALTH CARE PROVIDER WHO IS LICENSED OR CERTIFIED BY
- 15 <u>A COMMONWEALTH AGENCY FROM PRACTICING WITHIN THE SCOPE OF THAT</u>
- 16 LICENSE OR CERTIFICATE OR AS OTHERWISE AUTHORIZED BY LAW.
- 17 Section 2. This act shall take effect in 60 days.
