AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, providing for adoption assistance
- 3 programs; and making a repeal.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Chapter 25 of Title 23 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a subchapter to read:
- 8 SUBCHAPTER F
- 9 ADOPTION ASSISTANCE PROGRAM

- 11 2561. Purpose.
- 12 2562. Definitions.
- 13 2563. Rules and regulations.
- 14 2564. Adoption assistance payments and reimbursement.
- 15 § 2561. Purpose.

- 1 The purpose of this subchapter is to encourage and promote
- 2 the adoption of children who are physically, intellectually or
- 3 emotionally disabled or difficult to place by virtue of age,
- 4 sibling relationship or ethnicity.
- 5 § 2562. Definitions.
- 6 The following words and phrases when used in this subchapter
- 7 shall have the meanings given to them in this section unless the
- 8 context clearly indicates otherwise:
- 9 "Adoption assistance." Benefits provided to an adoptive
- 10 family on behalf of an eligible child, which may include medical
- 11 assistance and other applicable special services, a monthly cash
- 12 payment or reimbursement of nonrecurring adoption expenses.
- "Child." An individual who is under 21 years of age.
- 14 "Department." The Department of Public Welfare of the
- 15 Commonwealth.
- 16 "Eligible child." A child certified by a county children and
- 17 youth agency as to the following:
- 18 (1) the child's parental rights have been terminated
- 19 pursuant to this chapter;
- 20 (2) the child is in the legal custody of the county
- 21 children and youth agency or another agency approved by the
- 22 Department of Public Welfare; and
- 23 (3) the adoptive placement of the child may be difficult
- due to a physical, intellectual or emotional disability or by
- virtue of age, sibling relationship or ethnicity.
- 26 "Nonrecurring adoption expenses." Costs for home-study fees,
- 27 court costs, attorney fees and travel costs necessary to
- 28 complete the placement or adoption process.
- 29 § 2563. Rules and regulations.
- 30 (a) Duty of department.--The department shall establish and

- 1 develop criteria and promulgate regulations necessary for county
- 2 children and youth agencies to implement the adoption assistance
- 3 program in accordance with the provisions of this subchapter and
- 4 sections 470 through 476 of the Social Security Act (49 Stat.
- 5 620, 42 U.S.C. §§ 670 through 676).
- 6 (b) Rules and regulations.--It shall be the department's
- 7 responsibility to assure that no county children and youth
- 8 agency establishes policies or procedures that prevent the use
- 9 of adoption assistance benefits for eligible children.
- 10 (c) Content of regulations.--The regulations shall include,
- 11 but not be limited to, criteria for identifying eligible
- 12 children and adoptive homes, procedures for implementing the
- 13 adoption assistance agreement and reporting requirements by
- 14 county children and youth agencies.
- 15 (d) Adoption of regulations. -- All regulations established
- 16 pursuant to this section shall be adopted pursuant to the act of
- 17 July 31, 1968 (P.L.769, No.240), referred to as the Commonwealth
- 18 Documents Law, and the hearings referred to in section 202 of
- 19 the Commonwealth Documents Law shall be mandatory.
- 20 § 2564. Adoption assistance payments and reimbursement.
- 21 (a) Payments. -- The amount of adoption assistance cash
- 22 payment made to an adoptive family shall not exceed the monthly
- 23 payment rate for foster family care in the county in which the
- 24 child was determined eligible. For purposes of reimbursement of
- 25 nonrecurring adoption expenses, an eligible child need not be in
- 26 the legal custody of a county children and youth agency or other
- 27 agency approved by the department.
- 28 (b) Reimbursement to county. -- The department shall reimburse
- 29 county children and youth agencies for 100% of the cost of
- 30 adoption assistance provided by the county children and youth

- 1 agency pursuant to the provisions of this subchapter, provided
- 2 the agency complies with the reporting requirements established
- 3 by the department pursuant to section 2563 (relating to rules
- 4 and regulations).
- 5 (c) Exhaustion of benefits. -- No public funds shall be
- 6 expended under this subchapter on behalf of an eligible child
- 7 until all available benefits under existing or future private or
- 8 Federal, State or local programs have been exhausted.
- 9 Notwithstanding any other provision of law, adoptive families
- 10 subsidized under the provisions of this subchapter shall not be
- 11 liable under the act of June 24, 1937 (P.L.2045, No.397), known
- 12 as The Support Law, or the act of October 20, 1966 (3rd
- 13 Sp.Sess., P.L.96, No.6), known as the Mental Health and Mental
- 14 Retardation Act of 1966, in the event the adopted child needs
- 15 services or assistance under the provisions of the Mental Health
- 16 and Mental Retardation Act of 1966 or under Article IV of the
- 17 act of June 13, 1967 (P.L.31, No.21), known as the Public
- 18 Welfare Code.
- 19 Section 2. Subarticle (e) of Article VII of the act of June
- 20 13, 1967 (P.L.31, No.21), known as the Public Welfare Code, is
- 21 repealed.
- 22 Section 3. This act shall take effect in 60 days.
