AN ACT

- Providing a bonus to Pennsylvanians who are United States
 Merchant Marine veterans who served during World War II;
 imposing certain duties on the Adjutant General; providing penalties; and making an appropriation.

 The General Assembly finds and declares as follows:
- 6 (1) The United States Merchant Marine served with honor 7 and at great risk during World War II.
- 8 (2) Individuals serving in the United States Merchant
 9 Marine during World War II had a greater casualty rate than
 10 any branch of the armed forces.
- 11 (3) Dwight D. Eisenhower, in his capacity as General and 12 Supreme Commander Allied Expeditionary Force in Europe,
- observed in the midst of the war that, "When victory is

- finally ours, there is no organization that will share its
- 2 credit more deservedly than the Merchant Marine."
- 3 (4) Pennsylvania has recognized the honored service of
- 4 United States Merchant Marine veterans of World War II as
- 5 military service for purposes ranging from pension credit to
- 6 the National World War II Memorial christened in 2001.
- 7 (5) United States Merchant Marine veterans deserve to be
- 8 recognized and thanked for their service by the Commonwealth,
- 9 even at this late date, on a basis comparable to that given
- 10 to other veterans of World War II more than 50 years ago.
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. Short title.
- 14 This act shall be known and may be cited as the Merchant
- 15 Marine World War II Veterans Bonus Act.
- 16 Section 2. Definitions.
- 17 The following words and phrases when used in this act shall
- 18 have the meanings given to them in this section unless the
- 19 context clearly indicates otherwise:
- 20 "Adjutant General." The Adjutant General of the
- 21 Commonwealth.
- 22 "Legal resident of this Commonwealth." An individual who is
- 23 registered to vote as a resident of this Commonwealth on the
- 24 effective date of this act.
- 25 "Merchant Marine." The United States Merchant Marine.
- 26 "Merchant Marine veteran who served during World War II."
- 27 (1) The term includes any individual who served active
- duty, including training, in the United States Merchant
- Marine between December 7, 1941, and August 15, 1945.
- 30 (2) The term does not include:

- 1 (i) any individual at any time during such period,
- or thereafter, separated from the oceangoing United
- 3 States Merchant Marine under other than honorable
- 4 conditions;
- 5 (ii) any individual who renounced his United States
- 6 citizenship during such period; or
- 7 (iii) any individual who, during such period,
- 8 refused on conscientious, political, religious or other
- grounds to be subject to military discipline.
- 10 Section 3. Bonus.
- 11 A bonus of \$500 shall be payable under this act to any United
- 12 States Merchant Marine veteran who served during World War II
- 13 and is a legal resident of this Commonwealth.
- 14 Section 4. Application for bonus.
- 15 (a) General rule. -- Application for compensation shall be
- 16 made to the Adjutant General on such forms and in such manner as
- 17 the Adjutant General prescribes. A federally issued DD-214 form
- 18 evidencing honorable discharge from service in the United States
- 19 Merchant Marine for a period including any portion of the period
- 20 from December 7, 1941, through August 15, 1945, shall be deemed
- 21 sufficient evidence of qualifying service. The Adjutant General
- 22 shall assist applicants in obtaining copies of Federal DD-214
- 23 forms should the applicant desire assistance.
- 24 (b) Personal application; exception. -- An application shall
- 25 be made personally by the United States Merchant Marine veteran
- 26 who served during World War II and is a legal resident of this
- 27 Commonwealth. However, in the event that health or incompetency
- 28 prevent a personal application, then such representative of the
- 29 veteran as the Adjutant General shall prescribe shall serve as
- 30 attorney-in-fact for purposes of applying for and receiving the

- 1 bonus. An application made by a representative other than one
- 2 authorized by the Adjutant General shall be void.
- 3 (c) Acceptance and consideration of applications. -- The
- 4 Adjutant General shall not accept or consider any application
- 5 filed with the Adjutant General after December 31, 2003. The
- 6 decisions of the Adjutant General in consideration of
- 7 applications shall be final and not subject to review by any
- 8 court or by any other officer.
- 9 Section 5. Exemption from attachment.
- 10 No sum payable under this act to a United States Merchant
- 11 Marine veteran or any other person under this act shall be
- 12 subject to attachment, levy or seizure under any legal or
- 13 equitable process and shall be exempt from all State taxation.
- 14 No right to compensation under this act shall be assignable or
- 15 serve as a security for any loan. Any assignment or loan made in
- 16 violation of this section shall be held void.
- 17 Section 6. Penalty for fees for assisting with bonus
- 18 application.
- 19 Any person who charges or collects or attempts to charge or
- 20 collect, either directly or indirectly, any fee or other
- 21 compensation for assisting, in any manner, a veteran in
- 22 obtaining any of the benefits to which the veteran is entitled
- 23 under this act commits a misdemeanor and, upon conviction
- 24 thereof, shall be subject to a fine of not more than \$2,500, or
- 25 to imprisonment for not more than one year, or both, for each
- 26 violation.
- 27 Section 7. Digest and explanation of act.
- 28 The Adjutant General shall, as soon as practicable after the
- 29 effective date of this act, prepare and publish a pamphlet or
- 30 pamphlets containing a digest and explanation of this act,

- 1 accompanied by such statements as the Adjutant General believes
- 2 may be of assistance to the United States Merchant Marine
- 3 veterans who served during World War II in filing their
- 4 applications and shall from time to time prepare and publish
- 5 additional or supplementary information as may be found
- 6 necessary. The pamphlet or pamphlets shall be distributed in
- 7 such manner as the Adjutant General may determine to be most
- 8 effective to inform United States Merchant Marine veterans of
- 9 their rights under this act. The Adjutant General shall enlist,
- 10 as far as possible, the services of United States Merchant
- 11 Marine veteran organizations in this Commonwealth in the
- 12 dissemination of such information.
- 13 Section 8. Administration of act.
- 14 (a) General administration. -- The Adjutant General shall
- 15 administer this act and shall prepare and distribute
- 16 applications, investigate all claims and applications filed with
- 17 the Adjutant General and, if satisfied of the proof of such
- 18 claim or application, approve the application and direct payment
- 19 thereof. The Adjutant General shall make any regulation
- 20 necessary to administer this act.
- 21 (b) Records.--The books, papers and records, together with
- 22 the filing cases and equipment procured and used in the
- 23 administration of this act, shall become a part of the permanent
- 24 records of the office of Adjutant General.
- 25 (c) Oaths and affirmations.--Employees of the Department of
- 26 Military and Veterans Affairs, whose specific duty is to aid and
- 27 assist veterans and their widows, children and dependents in the
- 28 prosecution of claims before the Department of Veterans Affairs,
- 29 or other branch of the Federal Government, are hereby authorized
- 30 and empowered to administer oaths and affirmations in all

- 1 matters pertaining to and concerning such claims.
- 2 Section 9. Payment.
- 3 (a) Fund. -- The compensation payable under this act shall be
- 4 paid by the State Treasurer from the United States Merchant
- 5 Marine World War II Veterans' Bonus Fund to be administered by
- 6 the State Treasurer and created with funds realized from revenue
- 7 collected by the Commonwealth through what is known as the
- 8 emergency liquor tax and established by the act of June 9, 1936
- 9 (1st Sp.Sess., P.L.13, No.4), entitled, "An act imposing an
- 10 emergency State tax on liquor, as herein defined, sold by the
- 11 Pennsylvania Liquor Control Board; providing for the collection
- 12 and payment of such tax; and imposing duties upon the Department
- 13 of Revenue and the Pennsylvania Liquor Control Board," and shall
- 14 be appropriated each year to the fund. Any funds appropriated to
- 15 the United States Merchant Marine World War II Veterans' Bonus
- 16 Fund remaining unexpended or unencumbered upon the expiration of
- 17 this section shall lapse into the General Fund. Payments under
- 18 this act shall be made as soon as possible after funds are
- 19 available for such payments.
- 20 (b) Expiration.--This section shall expire June 30, 2004.
- 21 Section 10. Effective date.
- This act shall take effect immediately.
