AN ACT

- Amending the act of February 9, 1984 (P.L.3, No.2), entitled "An act providing for the education and training of deputy sheriffs; creating the Deputy Sheriffs' Education and Training Board under the Pennsylvania Commission on Crime and Delinquency; providing for the powers and duties of the board and the Attorney General; establishing the Deputy Sheriffs' Education and Training Account; providing for a surcharge on sheriffs' fees; and providing penalties," further providing for reimbursement to counties.
- 10 The General Assembly of the Commonwealth of Pennsylvania
- 11 hereby enacts as follows:
- 12 Section 1. Section 9 of the act of February 9, 1984 (P.L.3,
- 13 No.2), known as the Deputy Sheriffs' Education and Training Act,
- 14 is amended to read:
- 15 Section 9. Reimbursement to counties.
- 16 [The commission shall provide for reimbursement to each
- 17 county of 100% of the allowable tuition and the ordinary and
- 18 necessary living and travel expenses incurred by their deputy

- 1 sheriffs while attending certified deputy sheriffs' basic
- 2 training or continuing education schools if the county adheres
- 3 to the training standards set forth in this act and established
- 4 by the board with the review and approval of the commission. The
- 5 regular salary of deputy sheriffs while attending approved
- 6 schools shall be paid by the employing county. Fifty percent of
- 7 the regular salaries of deputy sheriffs while attending approved
- 8 schools shall be reimbursed to the employing county.] <u>Each</u>
- 9 <u>county shall pay the ordinary and necessary living and travel</u>
- 10 <u>expenses and the regular salary of their deputy sheriffs while</u>
- 11 <u>attending approved schools. The commission shall provide for</u>
- 12 reimbursement to each county of 100% of the regular salary of
- 13 their deputy sheriffs and 100% of the ordinary and necessary
- 14 living and travel expenses incurred by their deputy sheriffs
- 15 while attending certified deputy sheriffs' basic training or
- 16 continuing education schools if the county adheres to the
- 17 training standards set forth in this act and established by the
- 18 board with the review and approval of the commission. The
- 19 commission shall provide for 100% of the tuition incurred by
- 20 <u>deputy sheriffs while attending certified deputy sheriffs' basic</u>
- 21 training or continuing education schools.
- 22 Section 2. This act shall take effect in 60 days.
