AN ACT

Amending the act of December 20, 1985 (P.L.457, No.112), 2 entitled "An act relating to the right to practice medicine and surgery and the right to practice medically related acts; 3 reestablishing the State Board of Medical Education and Licensure as the State Board of Medicine and providing for its composition, powers and duties; providing for the issuance of licenses and certificates and the suspension and revocation of licenses and certificates; providing penalties; and making repeals, "further providing for physician 10 assistants. 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: 13 Section 1. Section 13(e) of the act of December 20, 1985 14 (P.L.457, No.112), known as the Medical Practice Act of 1985, is amended to read: 15 16 Section 13. Physician assistants. 17 (e) Written agreement. -- A physician assistant shall not 18

provide a medical service without a written agreement with one

or more physicians which provides for all of the following:

- 1 (1) Identifies and is signed by each physician the 2 physician assistant will be assisting.
- 3 (2) Describes the manner in which the physician 4 assistant will be assisting each named physician.
- 5 (3) Describes the nature and degree of supervision and 6 direction each named physician will provide the physician 7 assistant.
- 8 (4) Designates one of the named physicians as having the
 9 primary responsibility for supervising and directing the
 10 physician assistant.
- 11 (5) Has been approved by the board as satisfying the 12 foregoing and as consistent with the restrictions contained 13 in or authorized by this section.
- 14 A physician assistant shall not assist a physician in a manner
- 15 not described in the agreement or without the nature and degree
- 16 of supervision and direction described in the agreement. The
- 17 physician designated as having primary responsibility for the
- 18 physician assistant shall not have primary responsibility for
- 19 more than two <u>full-time equivalent</u> physician assistants.

- 21 Section 2. This act shall take effect in 60 days.
