AN ACT

- Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying and enumerating certain subjects of taxation and imposing 3 taxes thereon; providing procedures for the payment, 4 collection, administration and enforcement thereof; providing 6 for tax credits in certain cases; conferring powers and 7 imposing duties upon the Department of Revenue, certain 8 employers, fiduciaries, individuals, persons, corporations 9 and other entities; prescribing crimes, offenses and penalties," further providing for exclusions from sales and 10 11 use tax. The General Assembly of the Commonwealth of Pennsylvania 12
- 13 hereby enacts as follows:
- 14 Section 1. Section 204 of the act of March 4, 1971 (P.L.6,
- 15 No.2), known as the Tax Reform Code of 1971, is amended by
- 16 adding a clause CLAUSES to read:
- 17 Section 204. Exclusions from Tax. -- The tax imposed by
