AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled 2 "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, 3 primary and election expenses and election contests; creating 4 5 and defining membership of county boards of elections; 6 imposing duties upon the Secretary of the Commonwealth, 7 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 8 9 revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to 10 11 elections," further providing for regulation of polling 12 places. 13 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 14 15 Section 1. Section 1220 of the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, 16 amended August 31, 1971 (P.L.397, No.95), is amended to read: 17 18 Section 1220. Regulations in Force at Polling Places. -- (a) 19 Until the polls are closed, no person shall be allowed in the 20 polling place outside of the enclosed space at any primary or 21 election, except the watchers, voters not exceeding ten at any one time who are awaiting their turn to vote, and peace 22

- 1 officers, when necessary for the preservation of the peace. No
- 2 elector shall be allowed to occupy a voting compartment or
- 3 voting machine booth already occupied by another, except when
- 4 giving assistance as permitted by this act.
- 5 (b) No elector, except an election officer, clerk, machine
- 6 inspector or overseer, shall be allowed to re-enter the enclosed
- 7 space after he has once left it, except to give assistance as
- 8 provided by this act.
- 9 (c) No person, when within the polling place or on the
- 10 property on which the polling place is located, shall
- 11 electioneer or solicit votes for any political party, political
- 12 body or candidate[,]; nor shall any written or printed matter be
- 13 posted up [within the said room] anywhere on the property on
- 14 which the polling place is located, except as required by this
- 15 act.
- 16 (d) [All] No persons, except election officers, clerks,
- 17 machine inspectors, overseers, watchers, persons in the course
- 18 of voting, persons lawfully giving assistance to voters, and
- 19 peace and police officers[,] when permitted by the provisions of
- 20 this act, [must remain at least ten (10) feet distant from] are
- 21 permitted to be on the property on which the polling place is
- 22 <u>located</u> during the progress of the voting.
- 23 (e) When the hour for closing the polls shall arrive, all
- 24 qualified electors who have already qualified, and are inside
- 25 the enclosed space, shall be permitted to vote; and, in addition
- 26 thereto, all those qualified electors who are in the polling
- 27 place outside the enclosed space waiting to vote and all those
- 28 voters who are in line either inside or outside of the polling
- 29 place waiting to vote, shall be permitted to do so, if found
- 30 qualified.

- 1 (f) It shall be the duty of the judge of election to secure
- 2 the observance of the provision of this section, to keep order
- 3 in the voting room, and to see that no more persons are admitted
- 4 within the enclosed space than are permitted by this act. The
- 5 judge of election may call upon any constable, deputy constable,
- 6 police officer or other peace officer to aid him in the
- 7 performance of his duties under this section.
- 8 Section 2. This act shall take effect in 60 days.
