1 2 3 4 5	Requiring information relating to parenting and prenatal and postpartum depression, postpartum psychosis and other emotional trauma counseling to be provided to a pregnant woman; and providing for the powers and duties of the Department of Health.
6	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. Parenting and prenatal and postpartum counseling
9	information.
10	(a) Duty to provideA hospital, birthing center,
11	physician, nurse-midwife or midwife who provides prenatal care
12	to a pregnant woman during gestation or at delivery of an infant
13	shall:
14	(1) Provide the woman with a fact sheet that includes
15	common symptoms of prenatal and postpartum depression,
16	postpartum psychosis and other emotional traumas associated
17	with pregnancy and parenting.

- 1 (2) Provide the woman with a resource list of the names,
- 2 addresses and telephone numbers of professional organizations
- 3 that provide prenatal, postpartum counseling and assistance
- 4 to parents.
- 5 (3) Document in the patient's record that the patient
- 6 received the information described in paragraph (1).
- 7 (4) Retain the documentation for at least three years in
- 8 the hospital's, birthing center's, physician's, nurse-
- 9 midwife's or midwife's records.
- 10 (b) Resources to be included. -- The information under
- 11 subsection (a) shall include resources a pregnant woman may
- 12 contact to receive counseling and assistance for prenatal
- 13 depression, postpartum depression, postpartum psychosis and
- 14 other emotional traumas associated with pregnancy and parenting.
- 15 (c) Presumption of compliance. -- A hospital, birthing center,
- 16 physician, nurse-midwife or midwife who provides prenatal care
- 17 to a woman during gestation or at delivery is presumed to have
- 18 complied with this section if the woman received prior prenatal
- 19 care from another hospital, birthing center, physician, nurse-
- 20 midwife or midwife in this Commonwealth during the same
- 21 pregnancy.
- 22 Section 2. Powers and duties of the Department of Health.
- 23 The Department of Health shall:
- 24 (1) Adopt and promulgate rules and regulations necessary
- 25 to carry out the purposes and provisions of this act.
- 26 (2) Enforce this act and the rules and regulations
- 27 promulgated under this act.
- 28 (3) Make available on the department's World Wide Web
- 29 site a printable list of professional organizations that
- 30 provide prenatal depression, postpartum depression,

- 1 postpartum psychosis and other emotional traumas associated
- with pregnancy counseling and assistance to parents, along
- 3 with a fact sheet as referenced in section 1(a)(1).
- 4 (4) Update the list required under paragraph (3) on a
- 5 monthly basis.
- 6 Section 3. Effective date.
- 7 This act shall take effect in 60 days.
