## AN ACT

- Amending the act of August 5, 1941 (P.L.752, No.286), entitled 2 "An act regulating and improving the civil service of certain 3 departments and agencies of the Commonwealth; vesting in the State Civil Service Commission and a Personnel Director 5 certain powers and duties; providing for classification of 6 positions, adoption of compensation schedules and 7 certification of payrolls; imposing duties upon certain 8 officers and employes of the Commonwealth; authorizing 9 service to other State departments or agencies and political subdivisions of the Commonwealth in matters relating to civil 10 11 service; defining certain crimes and misdemeanors; imposing 12 penalties; making certain appropriations, and repealing certain acts and parts thereof, " further providing for 13 examination requisite for appointment and promotion. 14 15 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

- 17 Section 1. Section 501 of the act of August 5, 1941
- (P.L.752, No.286), known as the Civil Service Act, amended 18
- 19 November 27, 2002 (P.L.1129, No.140), is amended to read:
- 20 Section 501. Examinations Requisite for Appointment and
- 21 Promotion. -- (a) Except as otherwise provided in this act,
- appointments of persons entering the classified service or 22
- 23 promoted therein shall be from eligible lists established as the

- 1 result of examinations given by the director to determine the
- 2 relative merit of candidates. Such examinations may be written
- 3 and shall be competitive and open to all persons who may be
- 4 lawfully appointed to positions within the classes for which the
- 5 examinations are held, except that persons in unskilled
- 6 positions shall enter the classified service by promotion
- 7 without examination provided: (1) such promotion is into a
- 8 classified position immediately above the person's own position;
- 9 (2) such promotion is based on seniority and meritorious
- 10 service; (3) the person meets the minimum requirements for that
- 11 position; and (4) the person satisfactorily completes a six
- 12 month probationary period in the classified position. If no
- 13 persons in such unskilled positions meet the preceding
- 14 requirements, the vacant position may be filled pursuant to
- 15 Article V.
- 16 (b) Persons applying for positions or promotions in the
- 17 classified service shall be residents of the Commonwealth or
- 18 former residents of the Commonwealth who meet the requirements
- 19 of this subsection, and where applicable to the administrative
- 20 district. Former residents of the Commonwealth must have
- 21 relocated out of State for academic or employment purposes,
- 22 shall plan to establish Commonwealth residency within six months
- 23 of beginning employment in the classified service and must have:
- 24 (1) graduated from a public, private or nonpublic secondary
- 25 school in the Commonwealth within five years of applying for a
- 26 position in the classified service; [or] (2) attended a public,
- 27 private or nonpublic school in the Commonwealth at least eighty
- 28 percent of the time while enrolled in grades one through twelve
- 29 and attended such school within five years of applying for a
- 30 position in the classified service[.]; or (3) graduated or

- 1 attended a public, private or nonpublic secondary school in the
- 2 Commonwealth and graduated from a four year college, university
- 3 or technical school in the Commonwealth within five years of
- 4 applying for a position in the classified service.
- 5 Notwithstanding any of the provisions of this act, whenever an
- 6 appointing authority finds a lack of a sufficient number of
- 7 qualified personnel available for appointment to any particular
- 8 class or classes of positions, the appointing authority may
- 9 present evidence thereof to the director who may waive the
- 10 residence requirements for such class or classes of positions.
- 11 (c) The director shall prepare the proper State and district
- 12 employment and promotion eligible lists: Provided, That after an
- 13 examination has been conducted for any class of positions, if
- 14 there is no person with such legal residence in any
- 15 administrative district, remaining on the register the director
- 16 shall certify and the appointing authority may make the
- 17 appointment or promotion from the names of persons on an
- 18 appropriate eligible list for the same class of positions of
- 19 other administrative districts. Limitations as to age, sex,
- 20 health, moral character, experience and other qualifications may
- 21 be specified in the rules of the commission and in the
- 22 announcements of the examinations. All applications for
- 23 positions in the classified service shall be subject to the
- 24 penalties of 18 Pa.C.S. § 4904 (relating to unsworn
- 25 falsification to authorities).
- 26 (d) The commission may limit competition in promotion
- 27 examinations to employes in the classified service who have
- 28 completed their probationary period in a class or classes
- 29 designated in the public notice of the examinations, and may
- 30 permit promotions to be accomplished by any one of the following

- 1 plans: (1) by appointment from open competitive lists; or (2) by
- 2 achieving a place on an eligible list after a promotional
- 3 examination, such examination having been given at the request
- 4 of the appointing authority; or (3) by promotion based upon
- 5 meritorious service and seniority to be accomplished by
- 6 appointment without examination, if the person has completed the
- 7 probationary period in the next lower position and meets the
- 8 minimum requirements for the higher position.
- 9 (e) To the extent permitted by law, when all applicants for
- 10 appointment or promotion to a position in the classified service
- 11 are equally qualified, preference will be shown to applicants
- 12 who are United States citizens over those who are not.
- 13 Section 2. This act shall take effect in 60 days.
