- 1 WHEREAS, Throughout the month of May, the Pennsylvania
- 2 Motorcycle Safety Program, Alliance of Bikers Aimed Toward
- 3 Education of Pennsylvania (ABATE) and the Pennsylvania
- 4 Motorcycle Dealers Association (PMDA) are continuing their
