A RESOLUTION

- 1 Requesting that each member of Congress from Pennsylvania work 2 to make the Federal tax cuts permanent.
- 3 WHEREAS, Each year President Bush has proposed and the
- 4 Congress of the United States has enacted a tax cut designed to
- 5 strengthen the American economy and increase employment
- 6 opportunities for working families; and
- 7 WHEREAS, Tax cuts signed into law have reduced income taxes
- 8 for all taxpayers, eliminated the marriage penalty and death
- 9 tax, increased the child credit rebate and business expensing,
- 10 expanded Individual Retirement Accounts and cut the double
- 11 taxation of dividends and capital gains; and
- 12 WHEREAS, Economic growth stemming from the latest tax cut
- 13 accelerated at its fastest rate in 20 years in the third quarter
- 14 of 2003; and
- 15 WHEREAS, Provisions set forth in this tax cut are set to

- 1 expire starting in 2005 and will be completely phased out by the
- 2 year 2012; and
- 3 WHEREAS, Expiration of the existing tax cuts will increase
- 4 taxes by 50% for lower-income families, the child credit will
- 5 fall by 50%, the marriage penalty will be reinstated, education
- 6 savings will be taxed, retirement savings will shrink and every
- 7 taxpayer will face an income tax increase; and
- 8 WHEREAS, Expiration of the existing tax cuts will result in
- 9 the largest tax increase in American history and stifle economic
- 10 growth; and
- 11 WHEREAS, Making the tax cuts permanent will allow taxpayers
- 12 to feel more confident investing in their child's college
- 13 education or saving for retirement, all while ensuring increased
- 14 economic growth; therefore be it
- 15 RESOLVED, That the House of Representatives of the
- 16 Commonwealth of Pennsylvania request that each member of
- 17 Congress from Pennsylvania support and vote to make President
- 18 Bush's tax cuts permanent; and be it further
- 19 RESOLVED, That copies of this resolution be transmitted to
- 20 each member of Congress from Pennsylvania.
