AN ACT

- Amending the act of December 7, 1982 (P.L.784, No.225), 2 entitled, as amended, "An act relating to dogs, regulating the keeping of dogs; providing for the licensing of dogs and 3 4 kennels; providing for the protection of dogs and the 5 detention and destruction of dogs in certain cases; regulating the sale and transportation of dogs; declaring dogs to be personal property and the subject of theft; 7 8 providing for the abandonment of animals; providing for the 9 assessment of damages done to animals; providing for payment 10 of damages by the Commonwealth in certain cases and the liability of the owner or keeper of dogs for such damages; 11 12 imposing powers and duties on certain State and local 13 officers and employees; providing penalties; and creating a Dog Law Restricted Account," further providing for definitions and for seizure and detention; adding provisions 14 15 16 relating to cats; and providing for records and statistics. 17 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:
- 19 Section 1. Section 102 of the act of December 7, 1982
- 20 (P.L.784, No.225), known as the Dog Law, is amended by adding
- 21 definitions to read:
- 22 Section 102. Definitions.
- 23 The following words and phrases when used in this act shall

- 1 have, unless the context clearly indicates otherwise, the
- 2 meanings given to them in this section:
- 3 * * *
- 4 "Domestic animal shelter." Any facility which receives,
- 5 accepts or temporarily houses a domestic animal or releases a
- 6 domestic animal and all other animal control facilities,
- 7 <u>municipal shelters and pounds which are not covered under the</u>
- 8 <u>definition of humane society or association for the prevention</u>
- 9 of cruelty to animals. The term shall not include boarding
- 10 <u>kennels</u>.
- 11 <u>"Feral cat." A domestic cat that has reverted to the wild</u>
- 12 state after being lost or abandoned, or the offspring of such
- 13 cats who have lived in a wild state for some generations.
- 14 * * *
- 15 Section 2. Section 302 of the act, amended December 11, 1996
- 16 (P.L.943, No.151), is amended to read:
- 17 Section 302. Seizure and detention of dogs; costs; destruction
- of dogs; detention of cats.
- 19 (a) General rule.--It shall be the duty of every police
- 20 officer, State dog warden, employee of the department or animal
- 21 control officer to seize and detain any dog which is found
- 22 running at large, either upon the public streets or highways of
- 23 the Commonwealth, or upon the property of a person other than
- 24 the owner of such dog, and unaccompanied by the owner or keeper.
- 25 Every police officer, State dog warden, employee of the
- 26 department or animal control officer may humanely kill any dog
- 27 which is found running at large and is deemed after due
- 28 consideration by the police officer, State dog warden, employee
- 29 of the department or animal control officer to constitute a
- 30 threat to the public health and welfare.

- 1 (b) Licensed dogs.--The State dog warden or employee of the
- 2 department, the animal control officer, or the chief of police
- 3 or his agents of any city, borough, town or township, the
- 4 constable of any borough and the constable of any incorporated
- 5 town or township shall cause any dog bearing a proper license
- 6 tag or permanent identification and so seized and detained to be
- 7 properly kept and fed at any licensed kennel approved by the
- 8 secretary for such purposes and shall cause immediate notice, by
- 9 registered or certified mail with return receipt requested, to
- 10 the person in whose name the license was procured, or his agent,
- 11 to claim such dog within [five] six days after receipt thereof.
- 12 The owner or claimant of a dog so detained shall pay a penalty
- 13 of \$15 to the political subdivision whose police officers make
- 14 such seizures and detention and all reasonable expenses incurred
- 15 by reason of its detention to the detaining parties before the
- 16 dog is returned. If [five] six days after obtaining the postal
- 17 return receipt, such dog has not been claimed, such chief of
- 18 police, or his agent, or a constable, or State dog warden or
- 19 employee of the department shall dispense such dog by sale or by
- 20 giving it to a domestic animal shelter or a humane society or
- 21 association for the prevention of cruelty to animals. No dog so
- 22 caught and detained shall be sold for the purpose of
- 23 vivisection, or research, or be conveyed in any manner for these
- 24 purposes. All moneys derived from the sale of such dog, after
- 25 deducting the expenses of its detention, shall be paid through
- 26 the Department of Agriculture to the State Treasurer for credit
- 27 to the Dog Law Restricted Account.
- 28 (c) Unlicensed dogs.--Except as otherwise provided by
- 29 section 305, any police officer, State dog warden, employee of
- 30 the department or animal control officer shall cause any

- 1 unlicensed dog to be seized, detained, kept and fed for a period
- 2 of [48 hours] four days at any licensed kennel approved by the
- 3 secretary for such purposes, except any dog seriously ill or
- 4 injured or forfeited with the owner's permission. Any person may
- 5 view such detained dogs during normal business hours. Any
- 6 unlicensed dog remaining unclaimed after [48 hours] four days
- 7 may be humanely killed or given to a domestic animal shelter or
- 8 a humane society or association for the prevention of cruelty to
- 9 animals. No dog so caught and detained shall be sold for the
- 10 purpose of vivisection, or research, or be conveyed in any
- 11 manner for these purposes.
- 12 <u>(d) Cats.--</u>
- 13 (1) Any cat brought to a domestic animal shelter or a
- 14 humane society or association for the prevention of cruelty
- to animals shall be detained, kept and fed for a period of 48
- 16 hours, except any feral cat or cat seriously ill or injured
- or forfeited with the owner's permission.
- 18 (2) No cat detained shall be sold for the purpose of
- 19 vivisection, or research, or be conveyed in any manner for
- these purposes.
- 21 Section 3. The act is amended by adding a section to read:
- 22 Section 1202.1. Records and statistics maintained and
- published.
- 24 (a) Records and statistics. -- Every humane society or
- 25 <u>association for the prevention of cruelty to animals and a</u>
- 26 <u>domestic animal shelter shall keep detailed records of all</u>
- 27 domestic animals brought into its facility. These records shall
- 28 be forwarded quarterly to the Bureau of Dog Law Enforcement. The
- 29 Bureau of Dog Law Enforcement and each individual humane society
- 30 or association for the prevention of cruelty to animals and

- 1 domestic animal shelter shall make the following information
- 2 <u>available for public inspection on a quarterly basis:</u>
- 3 (1) the number of cats, kittens, dogs and puppies
- 4 <u>brought into the facility;</u>
- 5 (2) the number of cats, kittens, dogs and puppies
- 6 <u>adopted from the facility;</u>
- 7 (3) the number of cats, kittens, dogs and puppies
- 8 returned to the owner;
- 9 <u>(4) the number of cats, kittens, dogs and puppies</u>
- 10 <u>humanely killed at the facility;</u>
- 11 (5) the method used to humanely kill cats, kittens, dogs
- 12 <u>and puppies;</u>
- 13 (6) the manner in which the remains of cats, kittens,
- dogs and puppies were disposed;
- 15 (7) the number of cats, kittens, dogs and puppies which
- 16 <u>died at the facility;</u>
- 17 (8) the number and method of other dispositions for
- 18 cats, kittens, dogs and puppies which do not fall under the
- 19 above categories; and
- 20 (9) the holding capacity for cats, kittens, dogs and
- 21 puppies of the facility.
- 22 (b) Penalty.--Any person found in violation of this section
- 23 shall be quilty of a summary offense for the first violation and
- 24 for a second and subsequent violation which occurs within one
- 25 year of sentencing for the first violation shall be quilty of a
- 26 misdemeanor of the third degree.
- 27 Section 4. This act shall take effect in 60 days.
