- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 2 Statutes, further providing for UNATTENDED CHILDREN IN MOTOR 3 VEHICLES, FOR fleeing or attempting to elude police officer 4 AND FOR RESTRICTIONS ON HIGHWAY AND BRIDGE USE. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Section 3733(a) of Title 75 of the Pennsylvania Consolidated Statutes is amended and the section is amended by adding a subsection to read: 10 SECTION 3701.1(B) OF TITLE 75 OF THE PENNSYLVANIA SECTION 1. 11 CONSOLIDATED STATUTES IS AMENDED TO READ: 12 § 3701.1. LEAVING AN UNATTENDED CHILD IN A MOTOR VEHICLE. 13 14 (B) PENALTY. -- A PERSON WHO VIOLATES THIS SECTION COMMITS A 15 SUMMARY OFFENSE. IT IS A SEPARATE OFFENSE FOR EACH CHILD LEFT

- 1 SECTION IS AMENDED BY ADDING A SUBSECTION TO READ:
- 2 § 3733. Fleeing or attempting to elude police officer.
- 3 (a) Offense defined. -- Any driver of a motor vehicle who
- 4 willfully fails or refuses to bring his vehicle to a stop, or
- 5 who otherwise flees or attempts to elude a pursuing police
- 6 officer, when given visual or audible signal to bring the
- 7 vehicle to a stop, commits [a misdemeanor of the second degree.
- 8 Any driver upon conviction shall pay an additional fine of \$500.
- 9 This fine shall be in addition to and not in lieu of all other
- 10 fines, court expenses, jail sentences or penalties] an offense
- 11 <u>as graded in subsection (a.2)</u>.

- 13 <u>(a.2) Grading.--</u>
- 14 (1) Except as provided in paragraph (2), an offense
