## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 2 act relating to the public school system, including certain 3 provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the 4 laws relating thereto, " further providing for the excusal of 6 students for nonattendance during temporary periods. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 9 Section 1. Section 1329(a) of the act of March 10, 1949 10 (P.L.30, No.14), known as the Public School Code of 1949, 11 amended June 22, 2001 (P.L.530, No.35), is amended to read: 12 Section 1329. Excuses from Attending School.--(a) The board of school directors of any school district may, upon 13 14 certification by any licensed practitioner of the healing arts 15 or upon any other satisfactory evidence being furnished to it, 16 showing that any child or children are prevented from attending

school, or from application to study, on account of any mental,

physical, or other urgent reasons, excuse such child or children

- 1 but the term "urgent reasons" shall be strictly construed and
- 2 shall not permit [of] irregular attendance. In every such case,
- 3 such action by the board of school directors shall not be final
- 4 until the approval of the Department of Public Instruction has
- 5 been obtained. Every principal or teacher in any public,
- 6 private, or other school may, for reasons enumerated above,
- 7 excuse any child for non-attendance during temporary periods.
- 8 Any person picking up a child of compulsory school age having
- 9 been excused during school hours for a temporary period shall
- 10 show photo identification to the school's office staff prior to
- 11 signing out the child. If someone other than a parent or
- 12 <u>quardian of record is signing out the child, that person must</u>
- 13 <u>also have been authorized or documented in writing by the parent</u>
- 14 or quardian as someone having permission to sign out the child.
- 15 A person who is not authorized or documented as having
- 16 permission shall not be allowed to sign out the child from
- 17 school. Upon returning the child to school, the parent, quardian
- 18 or other authorized person must report with the child to the
- 19 school's office before the child may return to class. The form
- 20 of authorization or documentation required under this section
- 21 shall be determined by the board of school directors of each
- 22 school district.
