AN ACT

- Amending the act of April 14, 1972 (P.L.233, No.64), entitled 2 "An act relating to the manufacture, sale and possession of 3 controlled substances, other drugs, devices and cosmetics; conferring powers on the courts and the secretary and Department of Health, and a newly created Pennsylvania Drug, 5 Device and Cosmetic Board; establishing schedules of 7 controlled substances; providing penalties; requiring 8 registration of persons engaged in the drug trade and for the revocation or suspension of certain licenses and 9 registrations; and repealing an act, "further providing for 10 11 prohibited acts and penalties.
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. Section 13(c) of the act of April 14, 1972
- 15 (P.L.233, No.64), known as The Controlled Substance, Drug,
- 16 Device and Cosmetic Act, amended December 14, 1984 (P.L.988,
- 17 No.200), is amended and subsection (a) is amended by adding
- 18 clauses to read:
- 19 Section 13. Prohibited Acts; Penalties.--(a) The following

- 1 acts and the causing thereof within the Commonwealth are hereby
- 2 prohibited:
- 3 * * *
- 4 (39) The sale at retail of any product containing ephedrine,
- 5 pseudophedrine, phenylpropanolamine, or any of their salts,
- 6 optical isomers or salts of optical isomers as the sole active
- 7 ingredient unless one of the following applies:
- 8 (i) The product is offered for sale behind a counter where
- 9 the public is not permitted.
- 10 (ii) The product is offered for sale using any type of
- 11 antitheft device system, including, but not limited to, an
- 12 electronic antitheft device system that utilizes a product tag
- 13 and detection alarm which prevents the theft of the product.
- 14 (40) The delivery, in any single over-the-counter retail
- 15 <u>sale</u>, of more than three packages, or any number of packages
- 16 that contain a combined total of more than nine grams of any
- 17 product containing ephedrine, pseudoephedrine,
- 18 phenylpropanolamine, or any of their salts, optical isomers or
- 19 salts of optical isomers as the sole active ingredient, or in
- 20 combination with other active ingredients. This clause shall not
- 21 apply to any of the following:
- 22 (i) Pediatric products labeled pursuant to Federal
- 23 regulation primarily intended for administration to children
- 24 under 12 years of age according to label instructions.
- 25 (ii) Any compound, mixture, or preparation in liquid, liquid
- 26 <u>capsule</u>, or liquid gel capsule form if ephedrine,
- 27 pseudoephedrine or phenylpropanolamine is not the only active
- 28 <u>ingredient</u>.
- 29 (iii) Any compound, mixture, or preparation which has been
- 30 determined by the secretary to be formulated in such a way as to

- 1 <u>effectively prevent the conversion of the active ingredient into</u>
- 2 methamphetamine or its salts or optical isomers or salts of
- 3 optical isomers.
- 4 * * *
- 5 (c) Any person who violates the provisions of clauses (21),
- 6 (22) [and (24)], (24), (39) and (40) of subsection (a) shall be
- 7 guilty of a misdemeanor, and shall, on conviction thereof, be
- 8 punished only as follows:
- 9 (1) Upon conviction of the first such offense, he shall be
- 10 sentenced to imprisonment not exceeding six months, or to pay a
- 11 fine not exceeding ten thousand dollars (\$10,000), or both.
- 12 (2) Upon conviction of the second and subsequent offense, he
- 13 shall be sentenced to imprisonment not exceeding two years, or
- 14 to pay a fine not exceeding twenty-five thousand dollars
- 15 (\$25,000), or both.

- 17 Section 2. This act shall take effect in 60 days.
