## AN ACT

- Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public welfare laws of the Commonwealth," further providing for the
- 4 Health Care Provider Retention Program AND FOR REPORTING.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Sections 1302 A and 1310 A of the act of June 13, <--
- 8 1967 (P.L.31, No.21), known as the Public Welfare Code, amended
- 9 November 29, 2004 (P.L.1272, No.154), are amended to read:
- 10 SECTION 1. SECTION 1302-A OF THE ACT OF JUNE 13, 1967 <-
- 11 (P.L.31, NO.21), KNOWN AS THE PUBLIC WELFARE CODE, AMENDED
- 12 NOVEMBER 29, 2004 (P.L.1272, NO.154), IS AMENDED TO READ:
- 13 Section 1302-A. Abatement program.
- 14 There is hereby established within the Insurance Department a

- 1 program to be known as the Health Care Provider Retention
- 2 Program. The Insurance Department, in conjunction with the
- 3 department, shall administer the program. The program shall
- 4 provide assistance in the form of assessment abatements to
- 5 health care providers for calendar years 2003, 2004 [and], 2005,
- 6 2006 and 2007, except that licensed podiatrists shall not be
- 7 eligible for calendar years 2003 and 2004.
- 8 SECTION 2. SECTION 1306-A OF THE ACT, ADDED DECEMBER 23, <-
- 9 2003 (P.L.237, NO.44), IS AMENDED TO READ:
- 10 SECTION 1306-A. REPORTING.
- 11 (A) REPORTS.--BY MAY 15, 2004, THE INSURANCE DEPARTMENT
- 12 SHALL SUBMIT A REPORT TO THE GOVERNOR, THE CHAIRPERSON AND THE
- 13 MINORITY CHAIRPERSON OF THE BANKING AND INSURANCE COMMITTEE OF
- 14 THE SENATE AND THE CHAIRPERSON AND THE MINORITY CHAIRPERSON OF
- 15 THE INSURANCE COMMITTEE OF THE HOUSE OF REPRESENTATIVES
- 16 REGARDING THE PROGRAM. THE INSURANCE DEPARTMENT SHALL SUBMIT A
- 17 SECOND REPORT BY MAY 15, 2006. THE [REPORT] REPORTS SHALL
- 18 INCLUDE ALL OF THE FOLLOWING:
- 19 (1) THE NUMBER OF HEALTH CARE PROVIDERS WHO APPLIED FOR
- 20 ABATEMENT UNDER THE PROGRAM.
- 21 (2) THE NUMBER OF HEALTH CARE PROVIDERS GRANTED 100%
- 22 ABATEMENT UNDER THE PROGRAM.
- 23 (3) THE NUMBER OF HEALTH CARE PROVIDERS GRANTED 50%
- 24 ABATEMENT UNDER THE PROGRAM.
- 25 (4) BASED UPON AVAILABLE INFORMATION, THE NUMBER OF
- 26 HEALTH CARE PROVIDERS WHO HAVE LEFT THIS COMMONWEALTH AFTER
- 27 RECEIVING ABATEMENT UNDER THE PROGRAM.
- 28 (5) THE NUMBER OF AND REASON FOR ANY UNAPPROVED
- 29 APPLICATIONS.
- 30 (6) ANY OTHER INFORMATION RELEVANT TO ASSESSING THE

- 1 SUCCESS OF THE PROGRAM.
- 2 (B) EXCEPTION. -- A REPORT SHALL NOT RELEASE INFORMATION WHICH
- 3 COULD REASONABLY BE EXPECTED TO REVEAL THE INDIVIDUAL IDENTITY
- 4 OF A HEALTH CARE PROVIDER.
- 5 SECTION 3. SECTION 1310-A OF THE ACT, AMENDED NOVEMBER 29,
- 6 2004 (P.L.1272, NO.154), IS AMENDED TO READ:
- 7 Section 1310-A. Expiration.
- 8 The Health Care Provider Retention Program established under
- 9 this article shall expire December 31, [2006] 2008.
- 10 Section 2 4. This act shall take effect in 60 days. <----
