- 8 are active in 65 counties in this Commonwealth; and

- 4 WHEREAS, The agricultural industry and all the residents of

- 7 RESOLVED, That the House of Representatives designate April
- 8 12, 2005, as "Pennsylvania Farm Bureau Day."
