AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, further providing for definitions; and
- 3 providing for quality improvement of county agencies.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6303(a) of Title 23 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding definitions to read:
- 8 § 6303. Definitions.
- 9 (a) General rule. -- The following words and phrases when used
- 10 in this chapter shall have the meanings given to them in this
- 11 section unless the context clearly indicates otherwise:
- 12 * * *
- 13 "Accreditation." The recognition of an entity such as a
- 14 county or private agency as maintaining standards that affirm
- 15 the caliber of the services provided by the agency and afford
- 16 criteria by which the public may identify the standards for
- 17 efficient management and high-quality services.

- 1 "Accreditation agency." A nationally recognized child-care
- 2 and family-care service and behavioral health care accrediting
- 3 organization that promotes standards and champions quality
- 4 <u>services for children, youth and families.</u>
- 5 * * *
- 6 <u>"Prevention service." A service for children and their</u>
- 7 <u>families which is primarily designed to prevent child abuse and</u>
- 8 neglect, juvenile delinguency, juvenile dependency, school
- 9 dropouts, truancy, violence and the need for out-of-home
- 10 placements.

- 12 Section 2. Subchapter C of Chapter 63 of Title 23 is amended
- 13 by adding sections to read:
- 14 § 6350. County agency accreditation.
- 15 By January 1, 2008, county agencies providing child
- 16 protective services as defined in section 6303 (relating to
- 17 <u>definitions</u>) shall be accredited by an accreditation agency. The
- 18 department shall take appropriate action if a county agency has
- 19 not achieved accreditation by January 1, 2009.
- 20 § 6350.1 Department accreditation.
- 21 (a) Accreditation.--By January 1, 2008, the department shall
- 22 be accredited by an accreditation agency.
- 23 (b) Grants.--The department shall make available grants from
- 24 an amount to be appropriated by the General Assembly for county
- 25 <u>agencies and public and private agencies to obtain</u>
- 26 accreditation.
- 27 (c) Annual inspections.--If a county agency or public or
- 28 private agency has been accredited by an accreditation agency,
- 29 the agency shall not be subject to the requirements of the
- 30 department prescribed in 55 Pa. Code § 20.31 (relating to annual

- 1 <u>inspection</u>) unless deemed appropriate by the department.
- 2 Section 3. Section 6364 of Title 23 is amended to read:
- 3 § 6364. Purchasing services of other agencies.
- 4 (a) General rule. -- Any other provision of law
- 5 notwithstanding but consistent with sections 6361 (relating to
- 6 organization for child protective services) and 6362 (relating
- 7 to responsibilities of county agency for child protective
- 8 services), the county agency, based upon the plan of services as
- 9 provided in section 6363 (relating to county plan for protective
- 10 services), may purchase and utilize the services of any
- 11 appropriate public or private agency.
- 12 (b) Accreditation. -- A public or private agency providing
- 13 child protective services to a county agency shall be accredited
- 14 by an accreditation agency. Agencies receiving funds from the
- 15 <u>department or a county agency to provide prevention services</u>
- 16 shall also be accredited by an accreditation agency. A public or
- 17 private agency shall receive accreditation by January 1, 2008.
- 18 If after January 1, 2008, the agency has not been accredited,
- 19 the county agency shall not purchase the services of the public
- 20 <u>or private agency.</u>
- 21 Section 4. This act shall take effect in 60 days.
