AN ACT

- 1 Designating the bridge carrying State Route 1017, known as
- 2 Lycoming Creek Road, over Bottle Run, Old Lycoming Township,
- 3 Lycoming County, as the John Gross Memorial Bridge; AND
- 4 REDESIGNATING THE BRIDGE ON STATE ROUTE 36 IN THE BOROUGH OF
- 5 MAHAFFEY, CLEARFIELD COUNTY, AS THE PFC MELVIN L. BROWN
- 6 MEMORIAL BRIDGE.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. John Gross Memorial Bridge.
- 10 (a) Designation. -- The bridge carrying State Route 1017,
- 11 known as Lycoming Creek Road, over Bottle Run, Old Lycoming
- 12 Township, Lycoming County, is designated and shall be known as
- 13 the John Gross Memorial Bridge.
- 14 (b) Signs.--The Department of Transportation shall erect and
- 15 maintain appropriate signs which shall display the name of the
- 16 bridge designated in subsection (a) at each end of the bridge.

- 1 SECTION 2. PFC MELVIN L. BROWN MEMORIAL BRIDGE.
- 2 (A) REDESIGNATION. -- THE BRIDGE ON STATE ROUTE 36 IN THE
- 3 BOROUGH OF MAHAFFEY, CLEARFIELD COUNTY, IS REDESIGNATED THE PFC

- 4 MELVIN L. BROWN MEMORIAL BRIDGE.
- 5 (B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 6 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE TO
- 7 TRAFFIC IN BOTH DIRECTIONS.
- 8 Section $\frac{2}{3}$. Effective date.
- 9 This act shall take effect in 60 days.
