AN ACT

Amending the act of July 10, 1990 (P.L.404, No.98), entitled "An 2 act providing for the certification of real estate 3 appraisers; specifying requirements for certification; providing for sanctions and penalties; and making an 5 appropriation, " further providing for State Board of 6 Certified Real Estate Appraisers, for disciplinary and 7 corrective measures and for penalties. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 4(a) of the act of July 10, 1990 11 (P.L.404, No.98), known as the Real Estate Appraisers 12 Certification Act, is amended to read: 13 Section 4. State Board of Certified Real Estate Appraisers. 14 (a) Creation. -- There is hereby created the State Board of Certified Real Estate Appraisers as a departmental 15 administrative board in the Department of State. The board shall 16

- 1 (b) Civil penalty.--In addition to any other civil remedy or
- 2 criminal penalty provided for in this act, the board, by a vote
- 3 of the majority of the maximum number of the authorized
- 4 membership of the board as provided by law, or by a vote of the
- 5 majority of the duly qualified and confirmed membership or a
- 6 minimum of three members, whichever is greater, may levy a civil
- 7 penalty of up to [\$1,000] <u>\$10,000</u> on any [current]
- 8 certificateholder who violates any provision of this act or on
- 9 any person who holds himself or herself out as a certified real
- 10 estate appraiser or performs [appraisals for which certification
- 11 or licensure is required pursuant to the Financial Institutions
- 12 Reform, Recovery, and Enforcement Act of 1989 (Public Law 101-
- 13 73, 103 Stat. 183)] an appraisal in any federally related or
- 14 <u>nonfederally related transaction</u> without being [so] certified
- 15 pursuant to this act. The board shall levy this penalty only
- 16 after affording the accused party the opportunity for a hearing,
- 17 as provided in 2 Pa.C.S. (relating to administrative law and
- 18 procedure).

- 20 Section 4. This act shall take effect in 60 days.
