L2	Section 1. The title and sections 3(a) and 4 of the act of

- 5 Section 3. Powers of department.
- 6 (a) The Commonwealth of Pennsylvania, through the Department
- 7 of [Environmental] Conservation and Natural Resources,
- 8 hereinafter referred to as the department, is authorized
- 9 independent of any action by a municipality under section 4 to
- 10 enter into written cooperative agreements with political
- 11 subdivisions, landowners, private organizations and individuals
- 12 and to acquire by agreement, gift, eminent domain or purchase,
- 13 land, rights-of-way and easements for the purpose of
- 14 establishing, protecting and maintaining a walking trail right-
- 15 of-way across this Commonwealth, now generally known as the
- 16 Appalachian Trail, under such terms and conditions, including
- 17 payment by the department in lieu of property taxes on trail
- 18 lands or property so acquired or subject to such use in
- 19 accordance with the act of May 17, 1929 (P.L.1798, No.591)
- 20 referred to as the Forest Reserves Municipal Financial Relief
- 21 Law, as shall protect the interests of the actual or adjacent
- 22 landowners, or land users and as shall further the purposes of
- 23 this act. In the event of acquisition by eminent domain of land
- 24 other than tillable farmland, the total amount of land so
- 25 acquired shall not exceed an average of 125 acres per mile of
- 26 trail; and in the event of acquisition by eminent domain of
- 27 tillable farmland, such acquisition of such land shall be
- 28 limited to a footpath with a width of not more than 25 feet
- 29 across such land until the owner of such land evidences plans to
- 30 convert the land to nonfarming use. Any department or agency of

- 1 the Commonwealth, or any political subdivision, may transfer to
- 2 the department land or rights in land for these purposes, on
- 3 terms and conditions as agreed upon, or may enter into an
- 4 agreement with the department providing for the establishment

- 7 Section 4. Municipalities; powers and duties.
- 8 (a) Political subdivisions, including municipalities
- 9 [POLITICAL SUBDIVISIONS, INCLUDING MUNICIPALITIES] (A) A <-

- 10 <u>MUNICIPALITY</u> as defined in the Pennsylvania Municipalities
- 11 Planning Code, through which the Appalachian Trail passes shall
- 12 have the power and their duty shall be to take such action
- 13 consistent with applicable law, as at least an interim measure,
- 14 to preserve the natural, scenic, historic and esthetic values of
- 15 the trail and to conserve and maintain it as a public natural
- 16 resource. <u>Such action shall include</u>, but not be <u>limited to</u>, the
- 17 <u>adoption</u>, <u>implementation</u> and <u>enforcement of zoning ordinances as</u>
- 18 THE GOVERNING BODY DEEMS necessary to preserve those values.
- 19 Such municipalities may act hereunder in that section of the
- 20 municipality through which the Appalachian Trail passes without
- 21 zoning the entire municipality as required under section 605 of
- 22 the Pennsylvania Municipalities Planning Code.
- 23 (b) The Department of Community and Economic Development
- 24 shall assist municipalities in complying with the provisions of
- 25 this section by furnishing technical assistance relating to
- 26 zoning matters. THE DEPARTMENT OF COMMUNITY AND ECONOMIC
- 27 DEVELOPMENT SHALL NOTIFY EACH MUNICIPALITY WHICH IS REQUIRED TO
- 28 COMPLY WITH THE PROVISIONS OF SUBSECTION (E) WITHIN 30 DAYS OF
- 29 THE EFFECTIVE DATE OF THIS SUBSECTION.
- 30 <u>(c) The Department of Conservation and Natural Resources</u>

- 1 shall assist municipalities in the identification and
- 2 <u>acquisition of property appropriate for a conservation easement</u>
- 3 or other protection measures and provide information to
- 4 municipalities relating to protection measures such as
- 5 conservation easements and other techniques through its grant
- 6 programs, subject to availability of funding, eligibility, and
- 7 the terms, rules, procedures and requirements thereof.
- 8 (d) Municipalities which have not adopted ZONING ordinances <

- 10 shall receive priority for grant funding under the Land Use
