## AN ACT

Amending the act of December 22, 1975 (P.L.606, No.175), 2 entitled "An act authorizing and directing the Department of 3 General Services, or such department and The General State Authority, to convey to Philadelphia or transfer jurisdiction within the State government of certain tracts of Commonwealth 5 real property acquired under the act of September 29, 1938 7 (Sp. Sess., P.L.53, No.21), entitled, as amended, 'An act relating to institutions of counties, cities, wards, 8 boroughs, townships, institution districts and other 9 10 political subdivisions, for the care, maintenance, and treatment of mental patients; providing for the transfer to 11 the Commonwealth for the care, maintenance and treatment of 12 13 mental patients of such institutions, and all grounds, lands, buildings and personal property of such political 14 15 subdivisions used for the care and maintenance of indigent persons connected with such mental institutions; providing 16 17 for the management and operation or closing and abandonment thereof; and the maintenance of mental patients therein; 18 19 including the collection of maintenance in certain cases; 20 providing for the retransfer of certain property to counties, 21 cities, wards, boroughs, townships, institution districts and 22 other political subdivisions under certain circumstances; 23 conferring and imposing upon the Governor, the Department of 24 Welfare, the courts of common pleas and counties, cities, 25 wards, boroughs, townships, institution districts and other 26 political subdivisions certain powers and duties; prohibiting cities, counties, wards, boroughs, townships, institution 27 28 districts and other political subdivisions from maintaining 29 and operating institutions, in whole or in part, for the care 30 and treatment of mental patients; and repealing inconsistent laws,' imposing powers and duties on the Department of 31 32 Environmental Resources in connection with one such tract, 33 and providing for use of land conveyed to the City of

- 4 hereby enacts as follows:
- 5 Section 1. The act of December 22, 1975 (P.L.606, No.175),

- 2 maintaining and operating institutions, in whole or in part, for
- 3 the care and treatment of mental patients; and repealing
- 4 inconsistent laws, 'imposing powers and duties on the Department
- 5 of Environmental Resources in connection with one such tract,
- 6 and providing for use of land conveyed to the City of
- 7 Philadelphia, " is amended by adding a section to read:
- 8 Section 6.1. The parcels of land known as Tract A and Tract
- 9 B shall not be subject to any ordinance, resolution, rule or
- 10 regulation of the City of Philadelphia relating to zoning or
- 11 <u>land use.</u>
- 12 Section 2. This act shall take effect immediately.
