## AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, further providing for information
- 3 relating to other persons having contact with children.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6344.2 of Title 23 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 6344.2. Information relating to other persons having contact
- 9 with children.
- 10 (a) Applicability.--This section applies to prospective
- 11 employees applying to engage in occupations with a significant
- 12 likelihood of regular contact with children, in the form of
- 13 care, guidance, supervision or training. Such persons include
- 14 social service workers, hospital personnel, mental health
- 15 professionals, members of the clergy, counselors, librarians and
- 16 doctors. This section also applies to prospective sports
- 17 officials with a significant likelihood of regular contact with
- 18 children.

- 1 (b) Investigation.--Employers, administrators or supervisors
- 2 shall require an applicant to submit to all requirements set
- 3 forth in section 6344(b) (relating to information relating to
- 4 prospective child-care personnel). An employer, administrator,
- 5 supervisor or other person responsible for employment decisions
- 6 regarding an applicable prospective employee under this section
- 7 that intentionally fails to require the submissions before
- 8 hiring that individual commits a misdemeanor of the third
- 9 degree.
- 10 (b.1) Sports officials.--The Pennsylvania Interscholastic
- 11 Athletic Association, Inc., shall require persons seeking to
- 12 register as sports officials to submit the information set forth
- 13 <u>in section 6344(b) and shall be subject to the penalty under</u>
- 14 subsection (b) for intentional failure to require the
- 15 submissions.
- 16 (c) Grounds for denial. -- Each applicant shall be subject to
- 17 the requirements of section 6344(c).
- 18 (d) Departmental treatment of information.--Information
- 19 provided and compiled under this section by the department shall
- 20 be confidential and shall not be subject to the act of June 21,
- 21 1957 (P.L.390, No.212), referred to as the Right-to-Know Law.
- 22 This information shall not be released except as permitted by
- 23 the department through regulation. The department may charge a
- 24 fee to conduct a certification as required by section 6344(b)(2)
- 25 in accordance with the provisions of section 6344(h). The
- 26 department shall promulgate regulations necessary to carry out
- 27 this subsection.
- 28 Section 2. This act shall take effect in 60 days.
