AN ACT

- 1 Providing for restroom access for certain customers of retail
- 2 establishments and for a penalty.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 5 Section 1. Short title.
- This act shall be known and may be cited as the Restroom 6
- 7 Access Act.
- Section 2. Definitions. 8
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Customer." An individual who is lawfully on the premises of
- 13 a retail establishment and who uses an ostomy device or who
- 14 suffers from an inflammatory bowel disease, such as Crohn's
- 15 disease, ulcerative colitis or any other medical condition that
- requires immediate access to a toilet facility. 16
- "Retail establishment." A place of business open to the 17
- 18 general public for the sale of goods or services.

- 1 Section 3. Customer access to retail establishment toilet
- 2 facilities.
- 3 A retail establishment or an employee of a retail
- 4 establishment that has a toilet facility for its employees shall

- 5 allow a customer to use that facility during normal business
- 6 hours if all of the following apply:
- 7 (1) The toilet facility is not located in an area where
- 8 providing access would create an obvious health or safety
- 9 risk to the customer or an obvious security risk to the
- 10 retail establishment.
- 11 (2) A public restroom is not immediately accessible to
- 12 the customer.
- 13 (3) THE CUSTOMER PROVIDES THE RETAIL ESTABLISHMENT WITH
- 14 EVIDENCE THAT THE CUSTOMER USES AN OSTOMY DEVICE OR SUFFERS
- 15 FROM AN INFLAMMATORY BOWEL DISEASE, SUCH AS CROHN'S DISEASE,
- 16 ULCERATIVE COLITIS OR ANY OTHER MEDICAL CONDITION THAT
- 17 REQUIRES IMMEDIATE ACCESS TO A TOILET FACILITY, BY PROVIDING
- 18 DOCUMENTATION IN WRITING BY THE CUSTOMER'S PHYSICIAN OR AN
- 19 IDENTIFICATION CARD THAT IS ISSUED TO THE CUSTOMER BY A
- 20 NONPROFIT ORGANIZATION WHOSE PURPOSE INCLUDES SERVING
- 21 INDIVIDUALS WHO SUFFER FROM SUCH DISEASE OR CONDITION.
- 22 Section 4. Penalty.
- 23 A retail establishment or an employee of a retail
- 24 establishment that violates the provisions of this act commits a <-
- 25 summary offense. IS PUNISHABLE BY A CIVIL PENALTY OF UP TO \$500.
- 26 THE MAGISTRATE DISTRICT JUDGE FOR THE JURISDICTION IN WHICH THE
- 27 RETAIL ESTABLISHMENT IS LOCATED MAY IMPOSE THE CIVIL PENALTY
- 28 AUTHORIZED BY THIS SECTION.
- 29 Section 10 5. Effective date.
- 30 This act shall take effect immediately.
