AN ACT

Amending the act of December 22, 1983 (P.L.306, No.84), entitled 2 "An act providing for the State Board of Vehicle 3 Manufacturers, Dealers and Salespersons; and providing 4 penalties, " further defining "off premise sale, " "vehicle 5 show" or "exhibition"; defining "recreational vehicle show"; 6 further providing for grounds for disciplinary proceedings; 7 further providing for vehicle shows, off premise sales and exhibitions; providing for recreational vehicle shows, off 8 premise sales, exhibitions and rallies; and further providing 9 10 for vehicle shows, off premise sales and exhibitions on 11 Sundays. 12 AMENDING THE ACT OF DECEMBER 22, 1983 (P.L.306, NO.84), ENTITLED "AN ACT PROVIDING FOR THE STATE BOARD OF VEHICLE 13 14 MANUFACTURERS, DEALERS AND SALESPERSONS; AND PROVIDING 15 PENALTIES, "FURTHER PROVIDING FOR DEFINITIONS, FOR GROUNDS 16 FOR DISCIPLINARY PROCEEDINGS, FOR VEHICLE SHOWS, OFF-PREMISE 17 SALES AND EXHIBITIONS; PROVIDING FOR RECREATIONAL VEHICLE SHOWS, OFF-PREMISE SALES, EXHIBITIONS AND RALLIES; AND 18 19 FURTHER PROVIDING FOR VEHICLE SHOWS, OFF-PREMISE SALES AND 20 EXHIBITIONS ON SUNDAYS. 21 The General Assembly of the Commonwealth of Pennsylvania 22 hereby enacts as follows: 23 Section 1. The definition of "off premise sale," "vehicle show" or "exhibition" in section 2 of the act of December 22, 24 1983 (P.L.306, No.84), known as the Board of Vehicles Act, 26 amended April 19, 1996 (P.L.104, No.27), is amended and the

- 23 well as days when the events are not open shall be excluded.
