AN ACT

- 1 Amending the act of March 7, 1901 (P.L.20, No.14), entitled "An
- act for the government of cities of the second class,"
- further providing for penalty for false personification.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 1 of Article III of the act of March 7,
- 7 1901 (P.L.20, No.14), referred to as the Second Class City Law,
- 8 amended September 26, 1951 (P.L.1528, No.383) and July 17, 1953
- 9 (P.L.473, No.119), is amended to read:
- 10 Section 1. The department of public safety shall be under
- 11 the charge of one director, who shall be the head thereof. The
- 12 care, management, administration and supervision of the police
- 13 affairs, and all matters relating to the public health, to the
- 14 fire and police force, fire alarm telegraph, erection of fire-
- 15 escapes, and the inspection of buildings and boilers, markets

- 1 and food sold therein, and the construction, protection and
- 2 repair of buildings erected for police and fire purposes, shall
- 3 be in charge of this department.
- 4 No person shall be employed in this department as a policeman
- 5 or fireman who is not a citizen of the United States, or who has
- 6 been convicted of crime, unless pardoned, or who cannot read and
- 7 write understandingly in the English language, or who shall not
- 8 have resided within the State at least one year preceding his
- 9 appointment.
- 10 No policeman shall be required to be on duty for more than
- 11 nine out of any twenty-four consecutive hours, nor for more than
- 12 forty-four hours in any calendar week, and every policeman shall
- 13 be allowed to have at least forty-eight consecutive hours off
- 14 duty in every calendar week, except in emergency cases for the
- 15 suppression of riots or tumults or the preservation of the
- 16 public peace in times of riot, conflagration, or public
- 17 celebrations; and in such cases, council shall provide for the
- 18 payment of extra compensation or time off at the same rate as
- 19 paid for regular service. The existing salary or compensation of
- 20 any policeman shall not be diminished because of the reduced
- 21 number of hours of duty prescribed by this amendment.
- 22 The department shall make suitable regulations, under which
- 23 the officers and members of the fire, telegraph and police force
- 24 shall be required to wear an appropriate uniform. [It shall be a
- 25 misdemeanor, punishable by a fine not exceeding five hundred
- 26 (\$500) dollars and imprisonment not exceeding six (6) months, or
- 27 either or both, in the discretion of the court, for any person
- 28 to falsely personate by uniform, insignia or otherwise any
- 29 officer or member of the department.]
- 30 The city councils may provide by ordinance a fund for the

- 1 care, maintenance, and relief of aged, retired, disabled, or
- 2 injured policemen or firemen, and the families of such as may be
- 3 injured or killed in the service.
- 4 No policeman appointed under this act shall be dismissed
- 5 without his written consent, except by the decision of a court
- 6 either of trial or inquiry, duly determined and certified in
- 7 writing to the mayor, which court shall be composed of not less
- 8 than three and not more than five persons belonging to the
- 9 police force, equal or superior in official position therein to
- 10 the accused. Such decision shall only be determined by trial of
- 11 charges, with plain specifications made by or lodged with the
- 12 director of the department of public safety, of which trial the
- 13 accused shall have due notice, and at which he shall have the
- 14 right to be present in person. The persons composing such court
- 15 shall be appointed and sworn by the director of the department
- 16 of public safety to perform their duties impartially and without
- 17 fear or favor; and the person of highest rank in such court
- 18 shall have the same authority to issue and enforce process to
- 19 secure the attendance of witnesses, and to administer oaths to
- 20 witnesses, as is possessed by any justice of the peace of this
- 21 Commonwealth.
- 22 Such charges may be of disability for service, in which case
- 23 the court shall be one of inquiry, whose decision may be for the
- 24 honorable discharge from the service of the person concerned;
- 25 or, of neglect or violation of law or duty, inefficiency,
- 26 intemperance, disobedience of orders, or unbecoming official or
- 27 personal conduct, in which cases the court shall be one of
- 28 trial, and its decision may authorize the director of the
- 29 department of public safety to impose fines and pecuniary
- 30 penalties, to be stopped from pay, or to suspend from pay or

- 1 duty, or both, for a period fixed by them, not exceeding one
- 2 year, or to dismiss from the service. The right of appeal of the
- 3 decision of the trial board shall be made within five days to
- 4 the civil service board.
- 5 It shall be lawful for the director of the department of
- 6 public safety, at his discretion, to suspend from duty before
- 7 trial any person charged, as aforesaid, until such trial can be
- 8 had, with or without pay as such court shall afterward
- 9 determine, but no trial shall be delayed for more than one month
- 10 after charge has been made.
- 11 The finding of the court of trial or inquiry, as aforesaid,
- 12 shall be of no effect until approved by the mayor.
- 13 The laws in relation to health, buildings and building
- 14 inspection, remain unaffected by any of the provisions thereof,
- 15 and the board of health and the building inspectors shall remain
- 16 as heretofore, and shall be attached to the Department of Public
- 17 Safety.
- 18 Section 2. This act shall take effect in 60 days.
