AN ACT

1	Amending the act of April 12, 1951 (P.L.90, No.21), entitled, as
2	reenacted, "An act relating to alcoholic liquors, alcohol and
3	malt and brewed beverages; amending, revising, consolidating
4	and changing the laws relating thereto; regulating and
5	restricting the manufacture, purchase, sale, possession,
6	consumption, importation, transportation, furnishing, holding
7	in bond, holding in storage, traffic in and use of alcoholic
8	liquors, alcohol and malt and brewed beverages and the
9	persons engaged or employed therein; defining the powers and
10	duties of the Pennsylvania Liquor Control Board; providing
11	for the establishment and operation of State liquor stores,
12	for the payment of certain license fees to the respective
13	municipalities and townships, for the abatement of certain
14	nuisances and, in certain cases, for search and seizure
15	without warrant; prescribing penalties and forfeitures;
16	providing for local option, and repealing existing laws,"
17	further providing for the sale of liquor to licensees.
18	The General Assembly of the Commonwealth of Pennsylvania
19	hereby enacts as follows:
20	Section 1. Section 305(b) of the act of April 12, 1951 (P.L.
21	90, No.21), known as the Liquor Code, reenacted and amended June
22	29, 1987 (P.L.32, No.14) and amended July 6, 2005 (P.L.135, No.
23	39), is amended to read:

24 Section 305. Sales by Pennsylvania Liquor Stores.--* * *

1 (b) Every Pennsylvania Liquor Store shall sell liquors at 2 wholesale to hotels, restaurants, clubs, and railroad, pullman 3 and steamship companies licensed under this act; and, under the regulations of the board, to pharmacists duly licensed and 4 registered under the laws of the Commonwealth, and to 5 manufacturing pharmacists, and to reputable hospitals approved 6 by the board, or chemists. Sales to licensees shall be made at a 7 8 price that includes a discount of [ten] eighteen per centum from the retail price. The board may sell to registered pharmacists 9 10 only such liquors as conform to the Pharmacopoeia of the United 11 States, the National Formulary, or the American Homeopathic 12 Pharmacopoeia. The board may sell at special prices under the 13 regulations of the board, to United States Armed Forces 14 facilities which are located on United States Armed Forces 15 installations and are conducted pursuant to the authority and 16 regulations of the United States Armed Forces. All other sales by such stores shall be at retail. A person entitled to purchase 17 18 liquor at wholesale prices may purchase the liquor at any 19 Pennsylvania Liquor Store upon tendering cash, check or credit 20 card for the full amount of the purchase. For this purpose, the 21 board shall issue a discount card to each licensee identifying such licensee as a person authorized to purchase liquor at 22 23 wholesale prices. Such discount card shall be retained by the 24 licensee. The board may contract through the Commonwealth 25 bidding process for delivery to wholesale licensees at the 26 expense of the licensee receiving the delivery. 27 * * *

28 Section 2. This act shall take effect in 90 days.
