5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Sections 5301 and 5314 of Title 23 of the
8	Pennsylvania Consolidated Statutes are amended to read:
9	§ 5301. Declaration of policy.
10	The General Assembly declares that it is the public policy of
11	this Commonwealth, when in the best interest of the child, to
12	[assure] do all of the following:
13	(1) Assure a reasonable and continuing contact of the
14	child with both parents after a separation or dissolution of
15	the marriage and the sharing of the rights and
16	responsibilities of child rearing by both parents and
17	continuing contact of the child or children with grandparents

1 when a parent is deceased, divorced or separated.

2	(2) Assure reasonable and continuing contact of the
3	child with a sibling from whom the child has been separated
4	as a result of divorce, separation, death or court order.
5	§ 5314. Exception for adopted children.
6	Sections 5311 (relating to when parent deceased), 5312
7	(relating to when parents' marriage is dissolved or parents are
8	separated) [and 5313 (relating to when child has resided with
9	grandparents)], 5313 (relating to when grandparents may
10	petition) and 5316 (relating to sibling visitation) shall not
11	apply if the child has been adopted by a person other than a
12	stepparent or grandparent. Any visitation rights granted
13	pursuant to this section prior to the adoption of the child
14	shall be automatically terminated upon such adoption.
15	Section 2. Title 23 is amended by adding a section to read:
16	<u>§ 5316. Sibling visitation.</u>
17	(a) PetitionThe court may, upon petition of a sibling or
18	a child, grant reasonable visitation rights to the child if it
19	determines:
20	(1) That continuing contact between the petitioner and
21	the child is in the best interest of the child.
22	(2) In the case of a petitioner who is a child, that
23	visitation is in the best interest of the petitioner.
24	(3) That visitation would not interfere with the parent-
25	child relationship.
26	(b) Factors for considerationIn making a determination of
27	best interests under subsection (a), the court shall include the
28	following factors:
29	(1) The relationship between the child and the
30	petitioner. This paragraph includes the amount of personal
