AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing for definitions; and providing
- for regulation and operation of neighborhood electric
- 4 vehicles.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The definition of "motor vehicle" in section 102
- 8 of Title 75 of the Pennsylvania Consolidated Statutes, amended
- 9 November 26, 2008 (P.L.1658, No.133), is amended and the section
- 10 is amended by adding a definition to read:
- 11 § 102. Definitions.
- 12 Subject to additional definitions contained in subsequent
- 13 provisions of this title which are applicable to specific
- 14 provisions of this title, the following words and phrases when
- 15 used in this title shall have, unless the context clearly
- 16 indicates otherwise, the meanings given to them in this section:
- 17 * * *

- 1 "Motor vehicle." A vehicle which is self-propelled except an
- 2 electric personal assistive mobility device, a neighborhood
- 3 <u>electric vehicle</u> or a vehicle which is propelled solely by human
- 4 power.
- 5 * * *
- 6 "Neighborhood electric vehicle." A four-wheeled electric
- 7 <u>vehicle that has a maximum design speed of not less than 20</u>
- 8 miles per hour and of not more than 25 miles per hour and that
- 9 complies with the Federal safety standards established in 49 CFR
- 10 571.500 (relating to standard no. 500; low-speed vehicles).

- 12 Section 2. Chapter 35 of Title 75 is amended by adding a
- 13 subchapter to read:

- 17 3591. Scope of subchapter.
- 18 3592. Required equipment.
- 19 3593. Operation on certain highways or roadways.
- 20 3594. Certificate of title and registration required.
- 21 3595. License and financial responsibility required.
- 22 <u>3596. Exemption.</u>
- 23 § 3591. Scope of subchapter.
- 24 This subchapter applies to the operation of neighborhood
- 25 electric vehicles on certain highways or roadways in this
- 26 Commonwealth.
- 27 § 3592. Required equipment.
- A neighborhood electric vehicle shall be equipped in
- 29 <u>accordance with 49 CFR 571.500 (relating to standard no. 500;</u>
- 30 low-speed vehicles). This equipment shall include the following:

- 1 <u>(1) Headlamps.</u>
- 2 (2) Stop lamps.
- 3 <u>(3) Turn signal lamps.</u>
- 4 <u>(4) Reflex reflectors.</u>
- 5 <u>(5) Parking brake.</u>
- 6 (6) Rearview exterior mirror.
- 7 <u>(7) Rearview interior mirror.</u>
- 8 (8) Windshield.
- 9 <u>(9) Windshield wiper.</u>
- 10 <u>(10)</u> Speedometer.
- 11 <u>(11) Odometer.</u>
- 12 (12) Braking for each wheel.
- 13 <u>(13) Seat belts.</u>
- 14 (14) Vehicle identification number.
- 15 (15) Other equipment as required by Federal regulations.
- 16 § 3593. Operation on certain highways or roadways.
- 17 A neighborhood electric vehicle may be operated on any
- 18 highway or roadway where the posted speed limit is 35 miles per
- 19 hour or less. This section does not prohibit a person from
- 20 operating a neighborhood electric vehicle across an intersection
- 21 where the highway or roadway has a posted speed limit of more
- 22 than 35 miles per hour.
- 23 § 3594. Certificate of title and registration required.
- 24 A neighborhood electric vehicle shall be properly titled and
- 25 registered with the department as required by Chapters 11
- 26 (relating to certificate of title and security interests) and 13
- 27 <u>(relating to registration of vehicles).</u>
- 28 § 3595. License and financial responsibility required.
- 29 An operator of a neighborhood electric vehicle must have a
- 30 valid driver's license and maintain financial responsibility as

- 1 required by Chapters 15 (relating to licensing of drivers) and
- 2 17 (relating to financial responsibility).
- 3 <u>§ 3596. Exemption.</u>
- 4 A neighborhood electric vehicle shall be exempt from any
- 5 emissions testing required under this title or other law.
- 6 Section 3. This act shall take effect in 60 days.
