## AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, further providing for cruelty to
- 3 animals.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 5511(q) of Title 18 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding definitions and the
- 8 section is amended by adding a subsection to read:
- 9 § 5511. Cruelty to animals.
- 10 \* \* \*
- 11 (c.1) Use of live animals or fowl for targets at trap shoot
- 12 <u>or block shoot prohibited.--</u>
- 13 (1) A person commits a summary offense if that person
- 14 willfully organizes, operates or conducts a trap shoot or
- 15 block shoot in which live animals or fowl are used as

- 1 <u>targets.</u>
- 2 (2) Nothing in this subsection shall be construed to
- 3 apply to any activity which is authorized or permitted under
- 4 <u>34 Pa.C.S. (relating to game) or a special permit under 58</u>
- 5 <u>Pa. Code Ch. 147 (relating to special permits).</u>

- 7 (q) Definitions.--As used in this section, the following
- 8 words and phrases shall have the meanings given to them in this
- 9 subsection:

- 11 <u>"Fowl." A bird, except game birds as defined and regulated</u>
- 12 under 34 Pa.C.S. § 5102 (relating to definitions).

- 14 "Trap shoot" or "block shoot." An event during which
- 15 participants shoot or attempt to shoot targets that are:
- 16 <u>(1) launched or otherwise immediately presented to the</u>
- 17 shooter with electronic or mechanical assistance from a fixed
- 18 location or locations within a predefined shooting field; or
- 19 (2) affixed to a rope, chain or other tethering device
- when presented to the shooter.

- 22 Section 2. This act shall take effect in 60 days.
