AN ACT

- Amending Title 25 (Elections) of the Pennsylvania Consolidated Statutes, in voter registration, providing for the same day
- 3 registration of a qualified elector.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 1321 of Title 25 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a paragraph to read:
- 8 § 1321. Methods of voter registration.
- 9 An individual qualified to register to vote under section
- 10 1301(a) (relating to qualifications to register) may apply to
- 11 register as follows:
- 12 * * *
- 13 (5) Under section 1325.1 (relating to same day voter
- 14 registration).
- 15 Section 2. Title 25 is amended by adding a section to read:
- 16 § 1325.1. Same day voter registration.
- 17 (a) General rule. -- A qualified elector may register on
- 18 <u>election day by appearing in person at the polling place for the</u>

- 1 electoral district in which the individual maintains residence
- 2 by completing and submitting a registration application to the
- 3 judge of elections and providing proof of identification and
- 4 <u>residence.</u>
- 5 (b) Acceptable forms of identification. -- In addition to
- 6 providing a completed voter registration form, an applicant must
- 7 provide a valid form of identification, including any of the
- 8 <u>following government issued forms of identification:</u>
- 9 <u>(1) A valid driver's license or identification card</u>
- issued by the Department of Transportation.
- 11 (2) A valid identification card issued by another agency
- of the Commonwealth.
- 13 (3) A valid identification card issued by the United
- 14 States Government.
- 15 (4) A valid United States passport.
- 16 (5) A valid United States Armed Forces identification
- 17 card.
- 18 (c) Procedures for same day registration. --
- 19 (1) Upon certifying the eligibility of the qualified
- 20 elector, the judge of elections at the polling place shall
- issue a provisional ballot, provided by the county board of
- 22 elections, which is to be completed by the qualified elector
- 23 <u>and sealed in an envelope along with the voter registration</u>
- 24 application.
- 25 (2) Within ten days of an election, the Department of
- 26 State shall approve or deny a voter registration application
- 27 <u>pursuant to the provisions established in section 1328</u>
- 28 (relating to approval of registration applications).
- 29 (3) The provisional ballot shall not be counted until
- 30 the Department of State has approved the voter registration

- 1 <u>application</u>.
- 2 (4) The qualified elector shall be notified in writing
- 3 by the Department of State as to the approval or denial of a
- 4 <u>voter registration application.</u>
- 5 Section 3. Sections 1326(b) and 1327(c) of Title 25 are
- 6 amended by adding paragraphs to read:
- 7 § 1326. Time.
- 8 * * *
- 9 (b) Deadlines.--In the administration of voter registration,
- 10 each commission shall ensure that any applicant who is a
- 11 qualified elector is registered to vote in an election when the
- 12 applicant has met any of the following conditions:
- 13 * * *
- 14 (3.1) In the case of same day voter registration if the
- 15 <u>valid voter registration application of the applicant is</u>
- 16 <u>accepted in the appropriate electoral district by the</u>
- 17 <u>presiding judge of elections</u>.

- 19 § 1327. Preparation and distribution of applications.
- 20 * * *
- 21 (c) Distribution.--
- 22 * * *
- 23 (7) The secretary shall print and distribute same day
- voter registration applications to all polling places
- 25 throughout this Commonwealth. Along with the distribution of
- 26 such applications, the secretary shall also include
- 27 instructions to inform the applicant of the same day voter
- 28 <u>registration application process, the process for counting</u>
- 29 <u>the applicant's vote and verifying the applicant's</u>
- 30 eligibility.

- 2 Section 4. This act shall take effect immediately.
