## INTRODUCED BY D. EVANS, MARCH 5, 2010

SENATOR CORMAN, APPROPRIATIONS, IN SENATE, RE-REPORTED AS AMENDED, JUNE 30, 2010

## AN ACT

1 2	Making appropriations to the Trustees of the University of Pennsylvania.
3	The General Assembly of the Commonwealth of Pennsylvania
4	hereby enacts as follows:
5	Section 1. (a) The sum of <del>\$30,000,000</del> \$29,754,000, or as
6	much thereof as may be necessary, is hereby appropriated to the
7	Trustees of the University of Pennsylvania for the fiscal year
8	July 1, 2010, to June 30, 2011, for veterinary activities.
9	(b) The sum of <del>\$500,000</del> \$248,000, or as much thereof as may
10	be necessary, is hereby appropriated to the Trustees of the
11	University of Pennsylvania for the fiscal year July 1, 2010, to
12	June 30, 2011, for the Center for Infectious Diseases.
13	Section 2. (a) Payments to the University of Pennsylvania
14	on account of the appropriations shall be made quarterly by the
15	Secretary of Education on the basis of costs during the fiscal
16	year and shall be conditioned on continuing authority for
17	inclusion on the Board of Trustees of the University of

Pennsylvania of a minimum of four persons who are not elected 1 2 officials and who are appointed by the President pro tempore of 3 the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives and the Minority Leader of the 4 House of Representatives for terms of office coterminous with 5 that of the respective appointing authority; and shall be 6 7 further conditioned on these appointees receiving full voting 8 rights as members of the board of trustees.

9 (b) The University of Pennsylvania shall provide full, 10 complete and accurate information as may be required by the 11 Department of Education or the chairman or the minority chairman 12 of the Appropriations Committee of the Senate or the chairman or 13 the minority chairman of the Appropriations Committee of the 14 House of Representatives.

15 The University of Pennsylvania shall report its revenues (C) 16 and expenditures and present its financial statements in 17 accordance with generally accepted accounting principles and 18 procedures for educational institutions as set forth in the 19 "Higher Education Finance Manual (1975)" and the "Commonwealth 20 of Pennsylvania Budget Instructions for the State System of 21 Higher Education, State-Related Universities and Non-State-Related Colleges and Universities." 22

23 (d) The Trustees of the University of Pennsylvania shall 24 report on forms provided by the Department of Education to both 25 the chairman and minority chairman of the Appropriations 26 Committee of the Senate and the chairman and minority chairman 27 of the Appropriations Committee of the House of Representatives 28 by September 30, 2011, on how State-appropriated funds were 29 expended for fiscal year 2010-2011 to reduce the costs to Pennsylvania resident students or to provide services to 30
