AN ACT

1 Amending the act of November 30, 2004 (P.L.1596, No.203),  
2 entitled "An act establishing the Capitol Centennial  
3 Commission; providing for the commission's powers and duties;  
4 imposing a penalty; and providing for funding," further  
5 providing for members of the Capitol Centennial Commission.

6 The General Assembly of the Commonwealth of Pennsylvania  
7 hereby enacts as follows:

8 Section 1. Section 4 of the act of November 30, 2004  
9 (P.L.1596, No.203), known as the Capitol Centennial Commission  
10 Act, is amended to read:

11 Section 4. Commission.

12 (a) Establishment.--The Capitol Centennial Commission is  
13 hereby established. The commission shall consist of the  
14 following members:

15 (1) The Governor or a designee.

16 [(2) The Lieutenant Governor or a designee.]

17 (3) The President pro tempore of the Senate or a  
18 designee.

19 (4) The Majority Leader of the Senate or a designee.

1 (5) The Minority Leader of the Senate or a designee.

2 (6) The Speaker of the House of Representatives or a  
3 designee.

4 (7) The Majority Leader of the House of Representatives  
5 or a designee.

6 (8) The Minority Leader of the House of Representatives  
7 or a designee.

8 (9) The Chief Justice of the Supreme Court of  
9 Pennsylvania or a designee.

10 (10) The chairman of the Capitol Preservation Committee  
11 or a designee.

12 (b) Cochairpersons.--The following are appointed as  
13 cochairpersons of the commission:

14 [(1) The Lieutenant Governor.]

15 (2) The President pro tempore of the Senate.

16 (3) The Speaker of the House of Representatives.

17 (c) Meetings.--Meetings of the commission shall be called by  
18 the cochairpersons.

19 (d) Director.--The cochairpersons of the commission shall  
20 appoint a director or codirectors.

21 Section 2. Upon the ratification of the amendment to the  
22 Constitution of Pennsylvania abolishing the office of Lieutenant  
23 Governor, the Secretary of the Commonwealth shall cause the date  
24 of ratification to be published in the Pennsylvania Bulletin.

25 Section 3. This act shall take effect as follows:

26 (1) The amendment of section 4 of the act shall take  
27 effect upon publication in the Pennsylvania Bulletin of the  
28 ratification date of the amendment to the Constitution of  
29 Pennsylvania that abolishes the office of Lieutenant  
30 Governor.

1           (2) Section 2 of this act and this section shall take  
2 effect immediately.
