AN ACT

- 1 Prohibiting public funding of certain plaques projects.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Public
- 6 Construction Plaque Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- "Agency." A Commonwealth agency, a local agency, a judicial
- 12 agency or a legislative agency.
- "Commonwealth agency." Any of the following:
- 14 (1) Any office, department, authority, board, multistate
- agency or commission of the executive branch, an independent
- 16 agency and a State-affiliated entity. The term includes:

- 1 (i) The Governor's Office.
- 2 (ii) The Office of Attorney General, the Department
- 3 of the Auditor General and the Treasury Department.
- 4 (iii) An organization established by the
- 5 Constitution of Pennsylvania, a statute or an executive
- 6 order that performs or is intended to perform an
- 7 essential governmental function.
- 8 (2) The term does not include a judicial or legislative
- 9 agency.
- 10 "Judicial agency." A court of this Commonwealth or any other
- 11 entity or office of the unified judicial system.
- "Legislative agency." Any of the following:
- 13 (1) The Senate.
- 14 (2) The House of Representatives.
- 15 (3) The Capitol Preservation Committee.
- 16 (4) The Center for Rural Pennsylvania.
- 17 (5) The Joint Legislative Air and Water Pollution
- 18 Control and Conservation Committee.
- 19 (6) The Joint State Government Commission.
- 20 (7) The Legislative Budget and Finance Committee.
- 21 (8) The Legislative Data Processing Committee.
- 22 (9) The Independent Regulatory Review Commission.
- 23 (10) The Legislative Reference Bureau.
- 24 (11) The Local Government Commission.
- 25 (12) The Pennsylvania Commission on Sentencing.
- 26 (13) The Legislative Reapportionment Commission.
- 27 (14) The Legislative Office for Research Liaison.
- 28 (15) The Legislative Audit Advisory Commission.
- 29 "Local agency." Any of the following:
- 30 (1) Any political subdivision, intermediate unit,

- 1 charter school, cyber charter school or public trade or
- vocational school.
- 3 (2) Any local, intergovernmental, regional or municipal
- 4 agency, authority, council, board, commission or similar
- 5 governmental entity.
- 6 Section 3. Prohibition.
- 7 No agency may expend public funds for the purpose of
- 8 purchasing or producing a plaque or sign that identifies a
- 9 public official, architect, designer, contractor or other person
- 10 involved in a construction project that is partially or wholly
- 11 paid for with public funds.
- 12 Section 4. Effective date.
- 13 This act shall take effect immediately.
