A RESOLUTION

- 1 Recognizing, during the observation of "Women's History Month"
- in March 2009, the contributions of Dorothy Allen, Josephine
- Blow, Lois A. Fernandez, Minnie Moore-Johnson, Lillian Ray,
- Betty B. Richardson Smoot and Emma Wilson.
- 5 WHEREAS, March 2009 is "Women's History Month," and
- 6 Pennsylvania has many women who have contributed greatly to the
- 7 progress and tradition of this Commonwealth; and
- 8 WHEREAS, While many of these women have already received wide
- 9 recognition for their contributions, there are countless others
- 10 who are less well known but are nonetheless woven into the
- 11 fabric of our history; and
- 12 WHEREAS, Seven women of this Commonwealth who deserve
- 13 acclamation during "Women's History Month" have served the City
- 14 of Philadelphia for decades; and
- 15 WHEREAS, Dorothy Allen began the Barrett Educational

- 1 Community Center in 1976 to offer a safe haven for children and
- 2 youth and to provide resources, food and services to
- 3 neighborhood adults, personally financing the center and
- 4 continuing to work during acute illnesses and through personal
- 5 tribulation; and
- 6 WHEREAS, Ms. Allen recently turned over the center's
- 7 operation to her granddaughter, Tiphanie White, who now serves
- 8 as its executive director; and
- 9 WHEREAS, Josephine Blow has served as Chester Avenue Business
- 10 Association's president for the past 20 years, is a
- 11 committeeperson of the 51st Ward, a board member of the African
- 12 Cultural Alliance of North America and serves on planning
- 13 committees for Southwest Pride Day, Thomas Avenue Town Watch
- 14 National Night Out Celebration and Garden Homes; and
- 15 WHEREAS, Ms. Blow belongs to the Southwest EPIC Stakeholders
- 16 and its Safe Corridor program, the 12th Police District Advisory
- 17 Council, the South West Action Coalition, Project NEAT and
- 18 Intelligent Sisters Improving Selves (ISIS), is an elected
- 19 member of the board of the Southwest CDC Neighborhood Advisory
- 20 Committee and has been involved in the planning and
- 21 revitalization of the Chester Avenue business corridor; and
- 22 WHEREAS, Lois A. Fernandez holds a master's degree in urban
- 23 planning from Antioch College and worked for the City of
- 24 Philadelphia from 1970 to 1988, fighting gang violence, engaging
- 25 in parent counseling and supervising children in foster care, as
- 26 well as innovating social programs in the Philadelphia School
- 27 District; and
- 28 WHEREAS, Ms. Fernandez has played a significant role in
- 29 preserving and perpetuating African culture since 1972, which
- 30 was highlighted through her work on the host committee of the

- 1 Corporate Council of Africa's 2001 meeting in Philadelphia; she
- 2 founded ODUNDE, Inc., initiated the ODUNDE Festival in
- 3 Philadelphia in 1975 to celebrate African culture and has served
- 4 as ODUNDE, Inc.'s president for the past 30 years; and
- 5 WHEREAS, Ms. Fernandez has received numerous awards for her
- 6 vision and service, and, in 1967, she sued in Federal Court,
- 7 successfully, for the removal of the term "illegitimate" from
- 8 the birth certificates of babies of single mothers; and
- 9 WHEREAS, Minnie Moore-Johnson is the founder and chief
- 10 executive officer of Concerned Parents, Inc., a nonprofit
- 11 organization that provides services to citizens in Philadelphia
- 12 who are less fortunate, elderly, homeless, or ex-offenders; the
- 13 organization provides educational support, food, clothing,
- 14 affordable furniture and appliances and links clients with
- 15 service agencies to find additional resources and employment;
- 16 and she personally has increased the annual Concerned Parents,
- 17 Inc., senior citizens Thanksgiving dinner from 15 meals served
- 18 in 1968 to 25,000 meals served in 1988; and
- 19 WHEREAS, Dr. Moore-Johnson created the Job Development
- 20 program at Temple University, which offers courses on ex-
- 21 offender job training, as well as training in ex-offender social
- 22 work and job development, and has received numerous accolades,
- 23 honors and awards for her many contributions; and
- 24 WHEREAS, Betty B. Richardson Smoot has run a successful real
- 25 estate transactions and tax preparation office since 1968,
- 26 serving the people of west Philadelphia as a real estate
- 27 salesperson since 1953; and
- 28 WHEREAS, Ms. Smoot served for many years as executive
- 29 director of the Mt. Zion Unity Development Corporation, was a
- 30 founding member of the Schuylkill Women's Coalition, has been

- 1 very active at her church for more than 70 years and currently
- 2 serves as a member of the Business and Professional Women's
- 3 Ministry and the church choir, and is the recipient of numerous
- 4 awards for her community and governmental service; and
- 5 WHEREAS, In 2001, after serving as deputy to three drug
- 6 czars, Lillian Ray was appointed the first African-American
- 7 female drug czar of the City of Philadelphia, capping an
- 8 industrious career in law enforcement and community organization
- 9 combating drug violence and crime through efforts such as
- 10 Stinger Square Community Services, interracial sports leagues,
- 11 computer training centers, literacy classes, food pantries,
- 12 enrichment workshops and the creation of the Peace Wall Mural in
- 13 the heart of the racially torn Graysferry section of the city;
- 14 and
- 15 WHEREAS, The mother of nine children, Ms. Ray has received
- 16 numerous awards and honors and serves on many boards, most
- 17 notably the Interdisciplinary Youth Fatality Task Force,
- 18 Pennsylvania Justice Fellowship Task Force and Philadelphia
- 19 Health Management Corporation Advisory Board; and
- 20 WHEREAS, For many years, Emma Wilson was the unwavering force
- 21 and youth advocate at Dixon House, serving as director of Camp
- 22 Unami, a residential summer camp for city children in rural
- 23 Pennsylvania; supervising a program to provide summer jobs for
- 24 youth; making Dixon House available for group dances and
- 25 gatherings; and organizing trips for young people in order to
- 26 expand their horizons; and
- 27 WHEREAS, Ms. Wilson's commitment to youth and family safety
- 28 led to her involvement with the Safe Corridor Project and
- 29 despite recent personal health concerns, Ms. Wilson remains
- 30 active in the community; and

- 1 WHEREAS, The commitment to social and community involvement
- 2 exemplified by these seven women is worthy of celebration and
- 3 praise; therefore be it
- 4 RESOLVED, That the House of Representatives recognize, during
- 5 the observation of "Women's History Month" in March 2009, the
- 6 contributions of Dorothy Allen, Josephine Blow, Lois A.
- 7 Fernandez, Minnie Moore-Johnson, Lillian Ray, Betty B.
