1 Recognizing the Schreiber Pediatric Rehab Center for its service
2 to Lancaster County.

3 WHEREAS, This Commonwealth is always proud to recognize those
4 institutions which contribute to the well-being of their
5 communities and ultimately to all the citizens of Pennsylvania;

7 WHEREAS, The Schreiber Pediatric Rehab Center of Lancaster
8 County recently obtained a three-year accreditation by the
9 Commission on Accreditation of Rehabilitation Facilities (CARF)
10 for its Outpatient Medical Rehabilitation Programs - Single
11 Service (Pediatric Family-Centered); and

12 WHEREAS, One of only six facilities in the United States
13 accredited by the CARF for outpatient medical rehabilitation

1 programs, the Schreiber Pediatric Rehab Center has been
2 providing medical-based rehabilitation services for nearly 75
3 years to individuals 20 years of age or younger; and
